HORLEY DISTRICT GAS.

(Application for Special Order under the Gas Undertakings Acts, 1920 to 1934.)

NOTICE is hereby given that the Horley District Gas Company (hereinafter referred to as "the Company") whose principal office is at Station Road, Horley, in the county of Surrey, intend to apply to the Board of Trade for a Special Order under the Gas Undertakings Acts, 1920 to 1934, for all or some of the following purposes (that is to say):—

I. To authorise the Company to use certain lands for the construction of gasworks and for the manufacture and storage of gas and the conversion of residual products, a description of the proposed new works and of the land

which it is proposed to use for the purpose of gasworks may be inspected on or before the 12th day of December, 1941, at the Offices of the Company at Station Road, Horley, Surrey, by any local authority, company or person.

2. To confer further powers on the Company with regard to the making and storage of gas and the making, using, storage, utilisation, working up, conversion, purchase and distribution of residual products and materials arising from the manufacture of gas.

3. To authorise the Company to acquire or take on lease additional lands by agreement and to sell, dispose of or let on lease any lands, houses or buildings belonging to the Company and not required for the purposes of their undertaking.

4. To increase the capital and borrowing powers of the Company.

5. To confer further powers on the Company with regard to the following-levying and recovery of charges for special readings of meters: prevention of improper use of gas and cutting off supplies of gas when charges due for gas supplied or apparatus let by the Company on hire or hire-purchase have not been paid and as to mode of cutting off supplies of gas; breaking up, laying, maintaining and repairing pipes in streets bounding or abutting on the limits of supply for the time being of the Company for the purpose of supplying premises abutting upon any such street and being within the said limits; to relieve the Company from obligation to supply gas in such circumstances as may be defined in the Order; to enable the Company to compel consumers to repair fittings in case of danger; to authorise the placing of meters in positions approved by them; inspection, taking off, removing, testing, repairing and replacing of meters; notice of meetings; notice of election and opposition to election of directors; keeping of one register in lieu of register of shareholders and authentication of register of shareholders; further provisions with reference to the service of notices, demand notes and other documents; recovery of demands and penalties and of sums due for gas fittings, &c., and the inclusion of several sums in one summons.

6. To enable the Company to exercise all such powers as may be necessary or convenient for giving effect to the purposes of the Order and to confer upon them all such other powers as are usually conferred upon undertakers in connection with the supply of gas.

7. The Order will vary or extinguish all rights and privileges which would impede or interfere with its purposes and confer other rights and privileges.

8. To incorporate with the Order with or without modifications all or some of the provisions of the Companies Clauses Consolidation Acts, 1845 to 1889, the Gas Works Clauses Act, 1847, the Gas Works Clauses Act, 1871, and the Lands Clauses Acts and to repeal such of the provisions of the Acts and Orders relating to the Company as may be deemed expedient.
