SPECIAL ENACTMENTS (EXTENSION OF TIME) ACT, 1940.

Whereas the Mayor, Aldermen and Burgesses of the Borough of Brighouse (hereinafter called "the Corporation") have made application to the Minister of Health for the issue of an Order under the Special Enactments (Extension of Time) Act, 1940, so as:—

(a) To extend by three years the period limited by the Brighouse (Clifton Common) Compulsory Purchase Order, 1938, as confirmed by the Minister of Health's Brighouse (Clifton Common) Housing Confirmation Order, 1939, for the compulsory purchase of the lands specified in the schedule thereto which the Corporation are authorised to acquire but have not yet acquired.

(b) For the several purposes of this application or for purposes connected with incidental to or consequent on those purposes, to make any alteration or amendment of the above mentioned Order as may be necessary or desirable.

Notice is hereby given that the Minister will consider any objections or representations against the grant of the said application made in writing before the 15th day of December, 1941, by any person or body interested in the subject matter of the said application. Such objections or representations should be addressed to the Secretary, Ministry of Health, Whitehall, London, S.W.I., and copies should be sent at the same time to the Town Clerk, Brighouse, Yorks (W.R.).
