Given at Our Court at Buckingham Palace, this Ninth day of December, in the year of our Lord one thousand nine hundred and fortyone and in the Fifth year of Our Reign. GOD SAVE THE KING. I. Edward Algernon FitzRoy, Speaker of the House of Commons, do hereby give notice that I am satisfied, after consulting with His Majesty's Government, that the public interest requires that the House should meet at an earlier time than the 9th day of December, 1941.

By virtue, therefore, of the Resolution of the House of Commons of the 13th day of November 1 now give notice that the House shall meet on Monday, 8th December, 1941.
