#### RESERVOIRS (SAFETY PROVISIONS) ACT, 1930.

The Secretary of State for the Home Department hereby gives notice that he has made Regulations under the above Act amending the Regulations made under the Act in 1930. The effect of the Regulations is to amend the formal notice of appointment of an engineer to make inspection (form D) and the notice of receipt of Certificate or Report (form G), by requiring only the County in which a reservoir is situated to be given instead of its precise location.
