SPECIAL ENACTMENTS (EXTENSION OF TIME) ACT, 1940.

Whereas the Mayor, Aldermen, and Burgesses of the Borough of Croydon have made application to the Minister of Health for the issue of an Order under the Special Enactments (Extension of Time) Act, 1940, so as to extend by three years the period limited by the Croydon (Wilford Road and Forster Road Re-development Area) Compulsory Purchase Order, 1939, as confirmed by the Minister of Health's Croydon (Wilford Road and Forster Road Re-development Area) Housing Confirmation Order 1939, for the compulsory purchase of lands specified in the schedule to the Order which they are authorised to acquire but have not yet acquired.

Notice is hereby given that the Minister of Health will consider any objections or representations made in writing against the grant of the said application before the ninth day of March, 1942, by any persons or body interested therein.
