#### Office of the High Commissioner for India.

The Secretary of State for India has appointed Mr. Reginald Tovey, a Deputy Superintendent in the Mercantile Marine Office, Avonmouth to superintend the transfer of lascars or other persons, and to grant the certificate required under section 125 of the Merchant Shipping Act, 1894 (57 and 58 Vic. cap. 60).

The fee to be paid for every lascar or other person, in respect of whom such certificate is applied for, is limited to three shillings, and in no case is the total amount of fees in respect of one crew to exceed five pounds.

#### GOVERNMENT OF BURMA ACT, 1935.
