SPECIAL ENACTMENTS (EXTENSION OF TIME) ACT, 1940.

Whereas by section 37 of the Chichester Corporation Act, 1938, the period limited by the local Act of 1935 for the completion of the works authorised by that Act was extended to the first day of October, 1942.

And whereas the Mayor, Aldermen and Citizens of the City of Chichester have made application to the Minister of Health for the issue of an Order under the Special Enactments (Extension of Time) Act, 1940, to extend by three years the period limited by the said section 37 for the completion of the Works other than Work No. 2 authorised by section 20 of the local Act of 1935.

Notice is hereby given that the Minister of Health will consider any objections or representations made in writing before the 13th day of April, 1942, by any person or body interested therein.
