At the Court at *Buckingham Palace*, the 30th day of *April*, 1942.

PRESENT,

The KING's Most Excellent Majesty in Council.

WHEREAS there was this day read at the Board a Memorial from the Right Honourable the Lords Commissioners of the Admiralty, dated the 24th day of April, 1942, in the words following, viz. :—

"Whereas by Section 20 of the Greenwich Hospital Act, 1865, it is enacted, *inter alia*, that the Admiralty shall, from time to time, continue or appoint such Officers, Clerks, and Servants for the purposes of the Hospital and Schools as seem fit, and may (subject to the approval of Your Majesty in Council) fix the salaries of such Officers and Clerks:

"And whereas by Section 8 of the Greenwich Hospital Act, 1872, it is enacted that the provisions of Section 20 of the Greenwich Hospital Act, 1865, so far as the same relate to salaries shall extend to pecuniary benefits of any kind:

"And whereas by His late Majesty's Order in Council bearing date the 14th day of August, 1934,

certain scales of salary and emoluments were authorised for the Nursing Staff, Royal Hospital School, Holbrook:

"And whereas we are of opinion that these scales of salary and emoluments should be revised:

"And whereas Mr. E. E. Perrin, a Master in the Royal Hospital School, Holbrook, is eligible for the award of superannuation allowances from the funds of Greenwich Hospital in respect of his services at Holbrook to the 30th April, 1942:

"We beg leave humbly to recommend that Your Majesty may be graciously pleased, by Your Order in Council, to authorise the scales and emoluments of the Nursing Staff, Royal Hospital School, Holbrook, as shown on the annexed Schedule to take effect from the dates shown thereon, and to sanction the payment from the funds of Greenwich Hospital of a pension to Mr. E. E. Perrin at the rate of One hundred and twenty-one pounds, fifteen shillings and three pence (£121 15s. 3d.) per annum as from the 1st May, 1942, and a gratuity of Three hundred and twenty-four pounds, fourteen shillings (£324 14s. 0d.)."
