

THE BREN MANUFACTURING COMPANY LIMITED (PRICE OF SHARES) ORDER 1942 DATED THE 23RD APRIL 1942 MADE BY THE TREASURY UNDER REGULATION 78 OF THE DEFENCE (GENERAL) REGULATIONS 1939.

Whereas by the Bren Manufacturing Company Limited Control (No. 1) Order 1941 dated the 25th day of August 1941 the Minister of Supply (hereinafter referred to as "the Minister") authorised an authorised controller to exercise functions of control on behalf of His Majesty with respect to the undertaking carried on by the Company called the Bren Manufacturing Company Limited:

And whereas by the Bren Manufacturing Company Limited (Transfer of Shares) Order 1941 the Minister transferred all the shares of the Bren Manufacturing Company Limited to his nominees as specified in the Order:

And whereas the Treasury are of opinion that the price hereinafter specified as the price to be paid by the Minister in respect of the shares so transferred as aforesaid is not less than the value of those shares as between a willing buyer and a willing seller on the 25th day of August 1941 (being the date of the Bren Manufacturing Company Limited (No. 1) Control Order 1941):

Now, therefore, the Lords Commissioners of His Majesty's Treasury, in exercise of the powers conferred on Them by paragraph (5) of Regulation 78 of the Defence (General) Regulations 1939, hereby make the following Order:—

1. The price to be paid by the Minister in respect of the shares of the Bren Manufacturing Company Limited so transferred to his nominees as aforesaid shall be £1 per share.

2. This Order may be cited as the Bren Manufacturing Company Limited (Price of Shares) Order 1942.
