THE PUBLIC SCHOOLS ACT, 1868.

THE GOVERNING BODY OF RUGBY SCHOOL having, on the 2nd day of June, 1942, in virtue of the powers conferred upon them by the above-named Act, made a Statute in the terms appended hereto amending the existing Statutes of the said School, the said Statute is hereby published in the London Gazette in accordance with the provisions in that behalf contained in the said Act.

And Notice is hereby given, that any person, body of persons, or body corporate, authorized in that behalf by the said Act, may, within two months after the publication of this notification, petition His Majesty in Council to withhold His approval from the whole or any part of the said Statute.

STATUTE made by The Governing Body of Rugby School on the 2nd day of June, 1942.

That Statute XXXVII be varied by the addition at the end of the first paragraph of the following words:—" Provided that until the cessation of hostilities between the United Kingdom and Germany, Italy and Japan, an Exhibition awarded in the month of July in any year from (and including) the year 1942 onwards may be held in suspense for not more than two terms, during which the Exhibitioner elected may remain at the School, subject to the approval of the Governing Body or of the member of the Governing Body who awards the Exhibitions approval of the Governing Body of of the member of the Governing Body who awards the Exhibitions on their behalf; and in such a case the emoluments of the Exhibition shall become payable from the date at which the Exhibitioner shall commence his residence at a University or other approved place of Special Education."

## TENDERS FOR TREASURY BILLS

TENDERS FOR TREASURY BILLS.

1. The Lords Commissioners of His Majesty's Treasury hereby give notice that Tenders will be received at the Chief Cashier's Office, at the Bank of England, on Friday, the 26th June, 1942, at 1 p.m., for Treasury Bills to be issued under the Treasury Bills Act, 1877, the National Debt Act, 1889, and the National Loans Acts, 1939 to 1942, to the amount of 475,000,000.

2. The Bills will be in amounts of £5,000, £10,000, £50,000 or £100,000. They will be dated at the option of the tenderer on any business day from Monday, the 29th June, 1942, to Saturday, the 4th July, 1942, inclusive, and will be payable at three months after date,

3. The Bills will be issued and paid at the Bank of England.

4. Each Tender must be for an amount not less than £50,000, and must specify the date on which the bills required are to be dated, and the net amount per cent. (being an even multiple of one penny) which will be given for the amount applied for. Separate Tenders must be lodged for Bills of different dates.

Tenders must be made through a London

Banker, Discount House or Broker.

6. The persons whose Tenders are accepted will be informed of the same not later than the following day, and payment in full of the amounts of the accepted Tenders must be made to the Bank of England by means of Cash or a Banker's Draft on the Bank of England not later than 1.30 p.m. (Saturday 12 noon) on the day on which the relative Bills are to be dated.

7. Members of the House of Commons are not precluded from tendering for these Bills.

8. Tenders must be made on the printed forms which may be obtained from the Chief Cashier's Office, Bank of England.

9. The Lords Commissioners of His Majesty's Treasury reserve the right of rejecting any Tenders.
