Foot-and-Mouth Disease (Infected Areas) Special  
Order No. 15 of 1943.

Subject.

I. Contracts the Foot-and-Mouth Disease Infected Area around Winwick, Warrington, Lancashire, on 23rd March, 1943, to an area comprising the districts situate within approximately 5 miles of Winwick.

II. Releases such contracted Infected Area from restrictions on 30th March, 1943.
