The KING has been pleased to award the Edward Medal to William Charles Servis, in recognition of his gallantry in the following circumstances —
On the 26th July, 1942, Mr. Servis, together with Mr Edward Evans, a steeplejack, and an apprentice,

were at work at the top of a chimney in Chatham Dockyard Evans stood on a staging inside the chimney while the other two men were on the chimney itself engaged in splitting the stonework, when a piece of stone weighing about one cwt dropped on the staging and caused one of the supporting beams to break Evans was precipitated down inside the chimney to the bottom, about 110 feet below

Servis thought that there was a possibility that Evans might have fallen on to the accumulated soot at the bottom of the chimney and might still be alive He descended to the ground and tried to reach Evans through the bottom of the chimney This, however, proved impossible and, after procuring a boatswant's chair, he returned to the top curing a boatswain's chair, he returned to the top of the chimney and lowered himself down inside where, with difficulty, he was able to lash Evans to a board attached to a rope. He then pulled himself up and, with assistance, lifted up Evans, placed him in a Neil-Robertson stretcher, and lowered him to the ground. On examination, Evans was found to have been killed by the fall.

The work of rescue took about one hour, and during as minutes of this time Servis was inside the

during 35 minutes of this time Servis was inside the chimney where he had to work in the darkness and in a dusty atmosphere. He was exposed to heat and there were also fumes, which leaked past the damper. Servis was aware of the leakage of fumes. damper Servis was aware of the leakage of rumes as sulphur fumes were noticeable at the top of the chimney. He knew the risks, but he promptly faced them in order to rescue his fellow worker, and the careful arrangements he made and the manner in which the rescue was effected showed that he acted with coolness and determination and in no rash

APPOINTMENT OF ADJUDICATING OFFICERS

103,564 (3rd May, 1943)

Whereas it is expedient that the Council of the City of Carlisle (which Council and City are in this Order referred to as "the Council" and "the City" respectively) should be empowered to appoint Officers to be termed Adjudicating Officers to perform duties under the Poor Law Acts, 1930 to 1938, relating to the grant of relief and the reimbursement of the Council of the amount of any relief expended on their behalf

Now therefore the Minister of Health, in exercise of the powers conferred upon him by the Poor Law Act, 1930, and of all other powers enabling him in that behalf, hereby makes the following Order

Citation, &c

I—(I) This Order may be cited as the Carlisle (Adjudicating Officers) Order, 1943, and in its application to the City of Carlisle shall be read as one application to the City of Carlisle shall be read as one with the Public Assistance Order, 1930, as amended by the Public Assistance (Casual Poor) Order, 1931, as subsequently amended, the Public Assistance (Amendment) Order, 1939, the Public Assistance (Amendment) Order, 1940, the Public Assistance (Amendment) Order (No 2), 1940, and the Public Assistance (Amendment) Order, 1941, and modified by this Order

Provided that in case of any inconsistency the provisions of this Order shall prevail

(2) This Order shall come into operation on the 1st day of June, 1943

(a) to determine, in accordance with the statutory provisions and any rules, orders or regulations made by the Minister in that behalf, and, subject thereto, in accordance with any regulations made by the Council for the purpose, the nature and amount of relief (if any) to be given to applicants for relief within such classes or falling to be dealt with in such circumstances as the Council shall from time to time authorise,

(b) to make orders for the grant of relief

accordingly,

- (c) to reconsider periodically, in accordance with any rules, orders or regulations made by the Minister in that behalf, and, subject thereto, in accordance with any regulations made by the Council for the purpose, the cases of persons receiving relief within such classes or falling to be dealt with in such circumstances as the Council shall from time to time authorise, and to make any necessary orders with regard thereto. any necessary orders with regard thereto,
- (d) to report to the appropriate Committee or Sub-Committee of the Council all orders for relief made by him,
- (e) to refer for consideration by the appropriate Committee or Sub-Committee of the Council such of the cases falling to be dealt with by him under this Order as in his opinion should be dealt with by the Committee or Sub-Committee, and also any cases falling within such classes as the Council may from time to time direct,
- (f) to refer to the appropriate Committee or Sub-Committee of the Council for review or con-sideration any case in which a recipient of relief or an applicant for relief asks for reconsideration of the Adjudicating Officer's determination or proposed determination of his case,
- (g) to keep Relief Order Books and to make entries therein in accordance with the provisions of Article 22 of the Public Assistance Order, 1930, wherever he considers applications for relief or reconsiders cases in which relief has been granted,
- (h) to report to the appropriate Committee or Sub-Committee of the Council all cases in which an application for relief has been refused, or in which on reconsideration relief has been discontinued,
