> Milan, May 5. The Prince of Vaudemont, our Governor, has lately given Orders for paying to the Suijs Cantons the Sum of 36000 Livers, part of the Money due to them from the King of Spain, on account of the Suijs Forces he entertained in his Service during the late War. The Count Pirro Visconti has received from his Catholick Majesty, a Grant of the Dignity of a Grandee of Spain for himself and his Heirs for ever. The King has also given him the Office of Commissary General of this State, with Power to dispose of it for two Lives. The King has made Count Carlo Archinto, Nephew to Cardinal Archinto the Arch-Bishop of this Place, a Knight of the Golden-Fleece.

The Prince of Dombes, Paris, May 22. N. S.
