remainder postponed until such time as we and the Bishop may hereafter deem suitable: "Now, therefore, we, the Ecclesiastical Commis-sioners, with the consent of the Right Reverend Michael, Bishop of St. Albans (testified by his signing this Scheme) humbly recommend and propose that upon the day when any Order of Your Majesty in Council ratifying this Scheme shall be published in the London Gazette the provisions in the original Order relating to the said sum of $\frac{1}{2}6,253$ I7s. 4d. $\frac{1}{2}3$ per cent. Redemption Stock shall be varied as follows:—
