Rome, June 5. The Great Duke of Tuscany continues here, and has visited the several Churches to obtain the Indulgences which are granted on account of the Jubilee. The Pope has made him divers noble Presents, and has promised him several Relicks, and particularly the Body of St. Stephen, his Highness being Great Master of the Knights of the Order of St. Stephen, instituted by one of his Ancestors. The Great Duke of Tuscany resolving to be here *Incognito*, and not to receive or pay any Visits of Ceremony, the Pope invited him to the Palace, and being brought into a Chamber adjoining to that where the Consistory is held, when the Consistory was over and the Pope was retired, all the Cardinals that were there came to the Great Duke, and made him their Compliments. The Queen Dowager of Poland, and the Princes Alexander and Constantine her Sons, are still here. The Pope has wholly put off his Journey to *Porto Anzo*. The Prince of Monaco, Ambassador from France, has had Audience of the Pope, to acquaint him, that the Most Christian King is very well pleased with the choice he has made, of Signior *Gualtieri* to be his Nuntio at the Court of France.

Leghorne, June 6. The Gallies which attended the Great Duke of Tuscany to *Nettuno*, are come back to *Porto Ferrajo*; His Highness intends to return hither from Rome by Land, and may be expected about the middle of this month. A Ship belonging to this Place took lately in the *Levant* a Turkish Vessel, which was bound from *Scanderoon* to *Constantinople*, and laden with Coffee and Rice, and carried her to *Malta*. A French Vessel is come in here in 15 days from *Tunis*, the Matter whereof reports, that the Dey of *Tunis* was preparing to bring into the Field an Army of 16000 Men, and 30 Pieces of Cannon, but it was not known upon what design.

Venice, June 11. An Express was sent this week with further Instructions to Signior *Grimani*, Commissioner from this Republick in *Dalmatia*, who has renewed his Conferences with the Turkish Commissioner for settling the Limits in these Parts. Signior *Gabrisli Zorzi*, who was chosen to be Ambassador from this State at *Vienna*, being made a Procurator of *St. Mark*, is excused from that Employment, and the Senate have made choice of Signior *Baptista Nani*, to go to *Vienna* with the same Character.

From the Saxon Camp near *Riga*, June 8. *N. S.* We have received Advice, that the Swedish Army, which is encamped near *Riga*, has within these few days been joined by 4000 Men more from *Finland*, and that they expect a further Reinforcement of 6000. They continue to ply us very warmly from two Batteries they have lately made, the one in an Island, and the other on a flat Boat in the River *Dvina*, and they have made a Bridge from their side of the River to the said Island. Yesterday a Detachment from the Swedish Camp came over the River in Boats at *Jonsfrenhoff*; but the Forces that lately joined us from *Lithuania*, which are encamped over-against that Place, obliged them to repass the River with the loss of divers of their Men.

Mittaw, June 11. General *Fleming* is daily expected here from *Warsaw* in his way to the Saxon Camp near *Riga*, his Equipage being already arrived. The Swedes continue on the other side the *Dvina*; They have received a Reinforcement of 4000 Men, and expect to be joined very soon by 6000 more, after which 'tis said they will pass the *Dvina*, and attack the Saxons, who in the meantime are intrenching themselves. The Reports we have had, that the *Moscovites* were assembling some Troops in order to assist the Saxons by making a Diversion against the

The Swedes in Livonia, are contradicted by all our Advices from Moscow.

**Warsaw, June 11.** The King of Poland has caused Circular Letters to be writ to the several Palatinates, to refer to their Consideration in the Provincial Diets what may be fit to be done in the present Juncture of Affairs, and particularly in relation to the War with Sweden, as also to desire they will take care to pay the Arrears due to the Forces of the Crown, that so these Matters may be the better prepared for the Meeting of the General Diet, which the King declares he will Summon against Winter. The King having desired of the Crown General and the Great General of Lithuania, that while his own Forces are employed against the Swedes in Livonia, the Army under their Command may be posted near our Frontiers in order to act defensively, in case the Swedes should make an Inroad into the Territories of Poland; the Crown answered, that he could not do this with out Directions from the Reich; But the General of Lithuania has to far complied with the King's Desire, as to send him some of the Forces of that Duchy, upon condition, that the King take them into his own Pay.

**Dantzick, June 17.** The Forces which lately arrived in these Parts from Saxony, and are said to consist in 4000 Horse and 3000 Foot, continue their March with all possible Diligence to join the Saxon Army in Livonia; And a Train of Artillery is preparing at Marienbourg to be sent thither. The King of Poland is shortly expected at Marienbourg.

**Vizna, June 22.** The Lunenburg Envoy has had Audience of the Emperor, and delivered a Letter from the Elector of Hannover and the Duke of Cell, representing the Reasons of their sending their Troops over the Elbe to the Duke of Holstein's Assistance; And the Ministers of Sweden and Holstein have made Instances to this Court, that whereas most of the Princes Guarantors of the Treaty of Aitens, have caused their Forces to march, in order to oblige the Danes to keep within the Bounds prescribed by the said Treaty, his Imperial Majesty would order his Forces to act for the same purpose. But no Resolution is yet taken thereupon. Presently the Imperial Troops that are ordered to draw together on the Frontiers of Bohemia and Saxony, are arrived there, and the rest are marching thither with all Expedition. The Marquis of Truchesean is arrived here with a Commission from the Duke of Lorraine.

**Dresden, June 17.** The King of Poland is expected here in 3 or 4 weeks from Warsaw, and 'tis said, that Ministers from several Foreign Princes are expected here against that time, to negotiate Matters about restoring the Peace of the North. Four Regiments of Foot which were ordered to march to Holstein, are countermanded, and will be quartered on the Frontiers of Saxony to observe the Imperial Forces in Bohemia and Saxony.

**Be lin, June 18.** Major-General Archim is gone hence to Lentzen, where in it of the Brandenburg Forces, which are ordered to draw together, are already arrived, and Orders are given for sending thither a Train of Artillery.

**Hamburgh, June 22.** The Confederate Army continue in their Camp near Pinneberg. The Danes are removed from Elmshorne, and having passed the River Sawa over three Bridges of Boats, are encamped on this side thereof, about a German Mile from the Confederates. The Forces which the States-General have sent to the Assistance of the Duke of Holstein, are arrived at Hamburgh on the Elbe, where they are preparing to pass that River, in order to join the Confederate Army. In the mean time the Negotiations are continued, for restoring the Tranquility of these Parts, but nothing is yet concluded. The Letters from Copenhagen of the 15th Instant say, the Danish Fleet was coming back towards the Sound.

**Hague, June 25.** N. S. Deputies came hither this week from several Cities of the Province of Holland, to confer together touching the making the Lower Rhine and the River Yffel Navigable, but they separated without coming to any Resolution, because as this design would be advantageous to some Towns, so it would lessen the Trade of others. The Directors of the Dutch East-India Company met lately at Amsterdam, have resolved to make a Dividend of 15 per Cent. on the 15th of the next Month. The Swedish and other Foreign Ministers here continue to confer together about the Affairs of Holstein. The Baron Plejs is shortly expected here with the Character of Envoy from the Crown of Denmark.
