TENDERS FOR TREASURY BILLS.

1. The Lords Commissioners of His Majesty's Treasury hereby give notice that Tenders will be received at the Chief Cashier's Office, at the Bank of England, on Friday, the 27th August, 1943, at 1 p.m. for Treasury Bills to be issued under the Treasury Bills Act, 1877, the National Debt Act, 1889, and the National Loans Acts, 1939 to 1943, to the amount of £90,000,000.

2. The Bills will be in amounts of £5,000, £10,000, £50,000 or £100,000. They will be dated at the option of the tenderer on any business day from Monday, the 30th August, 1943, to Saturday, the 4th September, 1943, inclusive, and will be payable at three months after date.

3. The Bills will be issued and paid at the Bank of England.

4. Each Tender must be for an amount not less than £50,000, and must specify the date on which the Bills required are to be dated, and the net amount per cent. (being an even multiple of one penny) which will be given for the amount applied for. Separate Tenders must be lodged for Bills of different dates.

5. Tenders must be made through a London Banker, Discount House or Broker.

6. The persons whose Tenders are accepted will be informed of the same not later than the following day, and payment in full of the amounts of the accepted Tenders must be made to the Bank of England by means of Cash or a Banker's Draft on the Bank of England not later than 1.30 p.m. (Saturday 12 noon) on the day on which the relative Bills are to be dated.

7. Members of the House of Commons are not precluded from tendering for these Bills.

8. Tenders must be made on the printed forms which may be obtained from the Chief Cashier's Office, Bank of England.

9. The Lords Commissioners of His Majesty's Treasury reserve the right of rejecting any Tenders.

LONDON AND HOME COUNTIES JOINT ELECTRICITY AUTHORITY.

Election of Representatives of Workers in the Industry.

The Minister of Labour and National Service hereby gives notice that as soon as may be after

SPECIAL ENACTMENTS (EXTENSION OF TIME)
ACT, 1940.

COUNTY BOROUGH OF TYNEMOUTH.

Whereas the period limited by section 51 of the Tynemouth Corporation Act, 1934 (hereinafter called "the local Act"), for the compulsory purchase of lands authorised by the local Act and required for the purposes of (a) waterworks and water supply; (b) street improvement and (c) the purposes connected therewith mentioned in section 49 of the local Act was extended by section 4 of the Tynemouth Order, 1937, to the thirty-first day of December, 1940;

And whereas the Minister of Health (hereinafter called "the Minister"), with the concurrence of the Minister of Transport in relation to purpose (b) above, made an Order under the Special Enactments (Extension of Time) Act, 1940 (hereinafter called "the Act of 1940") further extending the said period to the thirty-first day of December, 1943;

And whereas section 9 of the local Act provides that the power to construct the waterworks authorised by the local Act shall cease on the expiration of a period of ten years from the passing of the Act, that is to say, on the twenty-fifth day of July, 1944;
