SPECIAL ENACTMENTS (EXTENSION OF TIME) ACT, 1940.

Lee Conservancy Catchment Board Act, 1938.

Under the Special Enactments (Extension of Time) Act, 1940, the Minister of Agriculture and Fisheries has made an Order modifying The Lee Conservancy Catchment Board Act, 1938 (Extension of Time) Order, 1941. The effect of the Order is to extend by three years from the thirty-first day of December, nineteen hundred and forty-four, the period for compulsory purchase of lands provided in Section 19 of the Lee Conservancy Catchment Board Act, 1938, as extended by the above-mentioned Order of 1941.
