The KING's Most Excellent Majesty in Council.

WHEREAS there was this day read at the Board a Memorial from the Right Honourable the Lords Commissioners of the Admiralty, dated the 21st day of February, 1945 (C.W. 45290/44), in the words following, viz.—

"Whereas by Section 3 of the Naval and Marine Pay and Pensions Act, 1865, it is enacted, *inter alia*, that all pay, pensions or other allowances in the nature thereof payable in respect of services in Your Majesty's Naval or Marine Force to a person being or having been on Officer, Seaman or Marine therein, shall be paid in such manner and subject to such restrictions, conditions and provisions as are from time to time directed by Order in Council:

"And whereas under the regulations for the Government of Your Majesty's Naval Service it is provided that Climate Pay may be paid during certain seasons to officers and men serving in specified localities at the following daily rates:—

"And whereas we consider that Climate Pay should be regarded as in the nature of compensation for the medical risks and discomforts of life afloat under tropical conditions, and that accordingly payment should be restricted exclusively to service afloat:

"And whereas the conditions of the present war have necessitated and may in future necessitate, changes in the areas, times, and other conditions of payment of Climate Pay:

"And whereas we consider that the rate of Climate Pay for Commissioned Officers and Commissioned Officers from Warrant rank should be reduced to 2s. od. a day:

"We beg leave humbly to recommend that Your Majesty may be graciously pleased by Your Order in Council to sanction, with effect from 1st October, 1943, payment of Climate Pay, in such areas, at such seasons, and subject to such conditions as may from time to time be agreed between us and the Lords Commissioners of Your Majesty's Treasury, at the following daily rates:—

TENDERS FOR TREASURY BILLS.

1. The Lords Commissioners of His Majesty's Treasury hereby give notice that Tenders will be received at the Chief Cashier's Office, at the Bank of England, on Thursday, the 29th March, 1945, at 1 p.m., for Treasury Bills to be issued under the Treasury Bills Act, 1877, the National Debt Act, 1889, and the National Loans Acts, 1939 to 1944, to the amount of £110,000,000.

2. The Bills will be in amounts of £5,000, £10,000, £25,000, £50,000 or £100,000. They will be dated at the option of the tenderer on any business day from Tuesday, the 3rd April, 1945, to Saturday, the 7th April, 1945, inclusive, and will be payable at three months after date.

3. The Bills will be issued and paid at the Bank of England.

4. Each Tender must be for an amount not less than £50,000 and must specify the date on which the Bills required are to be dated, and the net amount per cent. (being an even multiple of one penny) which will be given for the amount applied for. Separate Tenders must be lodged for Bills of different dates.

5. Tenders must be made through a London Banker, Discount House or Broker.

6. The persons whose Tenders are accepted will be informed of the same not later than the following day, and payment in full of the amounts of the accepted Tenders must be made to the Bank of England by means of Cash or a Banker's Draft on the Bank of England not later than 1.30 p.m. (Saturday 12 noon) on the day on which the relative Bills are to be dated.

7. Members of the House of Commons are not precluded from tendering for these Bills.

8. Tenders must be made on the printed forms which may be obtained from the Chief Cashier's Office, Bank of England.

9. The Lords Commissioners of His Majesty's Treasury reserve the right of rejecting any Tenders.
