



**Cologne, July 29.** The Elector of Cologne's new-raised Soldiers desert in great numbers. Orders are given at *Bon* for building Baracks for several Companies of Soldiers that are to come there; and the Inhabitants being apprehensive that a Foreign Garrison will be brought into the Town, divers of them began to send away their best Effects, but were forbid to do it. The Count of *Nassau Weiburgh* is expected in the Neighbourhood of this Place in 2 or 3 days, with the Forces which the Elector Palatine lends into the Service of the States-General.

**Brussels, August 2.** The Marshal *de Boufflers* came hither this day from *Louvain*, and will go to-morrow with the Marquis of *Beaumar* to review the Spanish Horse which are drawn together near *Chasteau*, and consist in 31 Squadrons, making in the whole, if they have their full Complement, about 3700 Men; The Foot will not be ready to be reviewed till the next month. The Count *de Tillyard* passed by *Luxemburgh* the 28th past with the Troops under his Command, in their march to the Duchy of *Limburch*, and the Marshal *de Villeroi* was expected at *Luxemburgh* yesterday. The Equipage of the Duke of *Maine* is arrived here from *France*. The French Forces are still cantoned, and the Country People are obliged to furnish them with Forage till such time as they encamp.

**Hague, August 2.** The 26th past, in the morning, His Majesty went from *Sas van Ghent* to the Fort of *Philippine*, where he embarked on board His Yacht, and landed at *Breskens* on the Isle of *Gadant*, and from thence went by Land to *Sluyce*, where His Majesty arrived in the evening, and was received with a General Discharge of the Artillery round the Place, having been Saluted in like manner as he passed by *Flushing* from the Walls and Ramparts of that City, as well as by 10 Dutch Men of War at Anchor in the Road. The 27th, His Majesty reviewed the Garrison of *Sluyce*, and viewed the new Works that are adding to the Fortifications of that Place, and observed at the same time the Forts of *St. Donst* and *Isabelle*, which the French are very busy in Fortifying, both these Places being within musket Shot of the Outworks of *Sluyce*. The 28th, His Majesty came from *Sluyce* to *Breskens*, where he embarked for *Bergenopzoom*, and was again Saluted as he passed that way by the Town of *Flushing*, and by the Men of War. The 29th, His Majesty came from *Bergenopzoom*, dined at *Sevenbergh*, and arrived here about midnight. His Majesty was Complimented the next day by the Foreign Ministers, and other Persons of Quality; and yesterday His Majesty went from hence to *Loo*.

Yesterday the Answer of the States-General to the Memorial, presented to them the 26th past by the Count *d'Avaux*, was delivered to him. He speaks of returning home by the way of *Brussels*, and making some stay in that Place, and of leaving a Secretary behind him, but has yet fixed no day for his departure. The Earl of *Macclesfield* went from hence this morning for *Hanover*. The Earl of *Marlborough* is at present here; He will receive this week the Visits of all the Foreign Ministers at Prince *Maurice's* House, which is lent him by the States. The States of *Holland* and *Westfriseland* are adjourned till *Thursday* next.

**Soefdyke, August 2.** Yesterday morning His Majesty came from the *Hague* to *Kruysberg*, between *Haerlem* and *Amsterdam*, where he lay last night, and arrived here this evening, intending to be to-morrow at *Loo*. All the Dutch Troops have notice to be in a readiness to take the Field, and will have Orders very soon to march out of their Garrisons and to encamp.

**Paris, August 3.** N. S. Yesterday the Earl of *Mandeville*, Ambassador Extraordinary from His Majesty of Great Britain, went to *Verfailles*, where he had Audience of the Dutchess Dowager of *Orleans*, to Condole with her in His Majesty's Name upon the Death of the late Duke of *Orleans*, and was introduced by *Montieu de Saimo*: Introducer of Ambassadors. The Ambassadors of *Venice* and *Savoy*, and several other Foreign Ministers, had Publick Audience of her Royal Highness, to make like Compliments of Condolence. Letters from *Turin* give an Account, that the Duke of *Savoy* arrived in the French Camp the 24th past; That he left the Administration of the Government in the hands of the Dutchess of *Savoy*, and appointed the Marquis *de Bagasco* Great Master of the Artillery, to Command all the Troops in the several Garrisons of *Savoy* and *Piedmont*. We have no News from the Armies in *Italy* since that is mentioned in our last.

**London, July 28.** On *Thursday* the 24th Instant was Launched at His Majesty's Yard at *Portsmouth* His Majesty's Ship the *St. George*, a Second Rate; And on *Friday* the 25th, was Launched at *Whitechapel* His Majesty's Ship the *Royal Sovereign*; a First Rate.
