The Lords Commissioners of His Majesty's Treasury hereby announce that they have made an Order sury hereby announce that they have made an Order under Section 20 of the Finance (No. 2) Act, 1940 entitled the Purchase Tax (Alteration of Rates) (No. 5) Order, 1945, directing that as from the 3rd November, 1945, Purchase Tax shall be reduced from $33\frac{1}{3}$ per cent. to $16\frac{2}{3}$ per cent. on household goods of celluloid, bakelite or other plastic material derived from cellulose, casein, papier maché or synthetic resin, being articles of a kind used in the preparation or serving of food or drink preparation or serving of food or drink.
