## TENDERS FOR TREASURY BILLS.

1. 3. The Bills will be issued and paid at the Bank of England.

4. Each Tender must be for an amount not less than £50,000 and must specify the date on which the Bills required are to be dated, and the net amount per cent. (being an even multiple of one penny) which will be given for the amount applied

for. Separate Tenders must be lodged for Bills of different dates.

5. Tenders must be made through a London Banker, Discount House or Broker.

6. The persons whose Tenders are accepted will be informed of the same not later than the following day and payment in full of the amounts of the accepted Tenders must be made to the Bank of England by means of Cash or a Banker's Draft on the Bank of England not later than 1.30 p.m. (Saturday 12 noon) on the day on which the relative Bills are to be dated.

7. Members of the House of Commons are not precluded from tendering for these Bills.

8. Tenders must be made on the printed forms which may be obtained from the Chief Cashier's Office, Bank of England.

9. The Lords Commissioners of His Majesty's Treasury reserve the right of rejecting any Tenders.

#### PETROLEUM (PRODUCTION) ACT, 1934.

In pursuance of Section 2 (3) of the Petroleum (Production) Act, 1934, the Minister of Fuel and Power hereby gives notice that in accordance with the provisions of that Act and of the Petroleum (Production) Regulations 1935, he has granted to the D'Arcy Exploration Company Limited, of Britannic House, Finsbury Circus, London, E.C.2, 10 prospecting licences in respect of the areas referred to in the Schedule hereto, the boundaries of which are described by reference to the one-inch Ordnance Survey Map.

#### SCHEDULE.

(1) An area of 194 square miles situate in the Counties of Buckingham, Hertford and Berkshire.

##### Northern Boundary:

Commencing at Aylesbury Station (Met. & G.C.Jt.R.) the boundary follows Akeman Street eastwards through Tring and then the road to Aldbury. From here the footpath across Aldbury Common is followed to its junction with the footpath from Ashridge to Berkhamsted.

##### Eastern Boundary:

Thence in a southerly direction to Northchurch and along the road to the centre of Berkhamsted. Continuing along the road generally southwards the boundary passes the village of Ashley Green to the Bovingdon Road by Leyhill Common. The county boundary is followed to Latimer and then the road through Chalfont St. Peter to the junction of roads A413 and A40 at Tatling End.

##### Southern Boundary:

The boundary proceeds in a south-westerly direction through the villages of Fulmer and Farnham Royal and across the River Thames at Taplow to the Slough-Maidenhead Road which is followed westwards to the Inn by Knowl Hill, thence along the road through Warren Row and Catchpole Green to the Ferry at Point 134, and along the river bank to the bridge at Henley on Thames.

##### Western Boundary:

Continuing along Henley Reach the river is followed to the bridge at Marlow where the boundary branches off in a northerly direction along road A404 to Point 305, across country to Waltons Ash by road through the village of West Wycombe to Bradenham Speen, Redland End, Great and Little Kimble, and then coincides with the G.W. & G.C. Rly. line to Aylesbury Station and the starting point.

(2) An area of 194 square miles situate in the Counties of Buckingham, Hertford and Middlesex.

##### Northern Boundary:

Commencing at the fork roads near the Lodge at Ringshall, the boundary proceeds in a general easterly direction through Little Gaddesden, along Gaddesden Row to Redbourne, and along the L.M. and S.R. line (Hemel Hempstead Branch) to Moreton End. From here due east to a point on the L. & N.E.R. about  $\frac{1}{2}$  mile north-west of Harpenden Station, and then the railway line is followed past Wheathamstead Station to a point about  $\frac{1}{2}$  mile north of the Ford at Waterend.

##### Eastern Boundary:

Continuing in a general southerly direction the boundary road passes the village of Sandridge, The Horse Shoes Inn by Wilkin's Green, skirts the town of St. Albans, passes London Colney, Shenley and Borehamwood as far as the L.M. & S.R. line about  $1\frac{1}{2}$  miles west of Mill Hill. From here the boundary road runs west to Stanmore, and south-eastwards to road A4006 by Kingsbury Station.

##### Southern Boundary:

The boundary continues along road A4006 passing Kenton, Harrow on the Hill and South Harrow Station to the L.N.E.R. at Wood End, then follows the railway for about 8 miles to the bridge over the road A413.

##### Western Boundary:

Continuing in a northerly direction the boundary roads and footpaths pass Chalfont St. Peter, Roughwood Park, Latimer, Leyhill Common and Ashley Green to road A41 in Berkhamsted. Road A41 is followed north-westward to the Lock at Northchurch where the canal is crossed and the boundary proceeds over Berkhamsted Common almost due north to the starting point.

(3) An area of 195 square miles situate in the Counties of Hertford, Middlesex and Essex.

##### Northern Boundary:

Commencing at the L.N.E.R. railway cutting about  $\frac{1}{2}$  mile south of Ayot Place, the boundary follows the railway in an easterly direction for about 9 miles to its junction with the L.N.E.R. main line at Hertford, thence through Hertford and along road A414 to Stanstead Abbots and to Roydon where the River Stort is followed as far as road A11.

##### Eastern Boundary:
