Notice is hereby given that the Minister of Agriculture and Fisheries, in exercise of the powers conferred upon him under Section 4 (3) of the Land Drainage Act, 1930, proposes to make an Order confirming a Scheme submitted to him by the River Wyre Catchment Board, under Section 4 (1) (b) of the Act, making provision for the following matters:—

1. The constitution of a new internal drainage district to be known as the Stalmine Preesall and Hambleton Internal Drainage District.
2. The constitution of a Drainage Board for the said Internal Drainage District.
3. Any matters supplemental to the above provisions.
