2. The carrying out of alterations to existing buildings and of operations required for the maintenance of existing buildings being development comprised within Class IV referred to in Article 4 of the said Order and not being development of any other class.

The carrying out of alterations to or operations required for the maintenance of any building the cost of which does not exceed the sum of one hundred pounds per annum or 25 per cent. per annum of the gross annual value of the property whichever may be the greater.
