SPECIAL ENACTMENTS (EXTENSION OF TIME) ACT, 1940.
 CITY OF SHEFFIELD.

Notice is hereby given that the Minister of Health in pursuance of the powers conferred on him by section 1 of the Special Enactments (Extension of Time) Act, 1940, has made the following Orders:—

1. The Sheffield (Extension of Time) Order, 1946, for further extending by three years the period limited by section 10 of the Sheffield Corporation Act, 1937, for the exercise by the Sheffield Corporation of the powers conferred on them by paragraph (a) of section 6 of that Act, except for the purposes of street improvements;
2. The Sheffield (Extension of Time) Order (No. 2), 1946, for further extending by two years the period limited by section 10 of the Sheffield Corporation Act, 1937, for the exercise by the Sheffield Corporation of the powers conferred on them by paragraph (a) of section 6 of that Act, relating to the purposes of street improvements;
3. The Sheffield (Extension of Time) Order (No. 3), 1946, for further extending by two years the period limited by section 8 of the Sheffield Corporation Act, 1939, for the exercise by the Sheffield Corporation of the powers conferred on them by paragraph (g) of subsection (1) of section 5 of that Act, and for further extending by three years the period limited by section 8 of that Act for the exercise by the Sheffield Corporation of the powers conferred on them by paragraphs (b) to (f) of subsection (1) of section 5 of that Act.
