*Civil Service Commission, 22nd October, 1946.*

The Civil Service Commissioners hereby give notice of the cancellation of the clauses in regulations issued by them relating to recruitment to posts in the established Civil Service, which provide that women candidates must be unmarried or widows and that women will ordinarily be required to resign their appointments on marriage.

This notice applies to all regulations issued by the Civil Service Commissioners which have been published in the London Gazette with the exception of the Temporary (Reconstruction) Regulations for filling vacancies in the Senior Branch of the Foreign Service.

**WATER ACT, 1945.**

**COUNTIES OF BEDFORD AND BUCKINGHAM.**

Notice is hereby given that the Minister of Health in pursuance of the powers conferred upon him by Section 14 of the Water Act, 1945, proposes to make an order defining an area consisting of the Urban Districts of Amphill, Biggleswade and Leighton Buzzard, part of the Urban District of Sandy, and parts of the Rural Districts of Amphill, Biggleswade and Luton in the County of Bedford, the Urban District of Linslade, and parts of the Rural Districts of Newport Pagnell and Wing in the County of Buckingham, as an area in which the provisions of the said Section 14 shall apply.

Copies of the draft order and the relevant map may be inspected at the Ministry of Health, Caxton House, Tobhill Street, S.W.1, the County Hall, Aylesbury, and the Shire Hall, Bedford.
