vision for their pay: "And whereas we consider that certain rating observers, although obsolescent, should be allowed to retain their existing rating and be paid on the scale applicable to rating pilots: "We beg leave humbly to recommend that Your Majesty by Your Order in Council, may be graciously pleased to sanction the rates of pay and conditions of payment of rating pilots set out in the accompanying Schedule, with effect from 1st July, 1946, or such later date as we may determine, and their application to rating observers during the remainder of their service. "The Lords Commissioners of Your Majesty's Treasury have signified their concurrence in these proposals.

propose that upon and from the day of the date of the publication in the London Gazette of any Order of Your Majesty in Council ratifying this Scheme and without any conveyance or assurance in the law other than such duly gazetted Order, the whole advowson or perpetual right of patronage of and presentation to the said benefice shall be transferred to the said Edward, Bishop of Lichfield, and his successors in the same Bishopric and shall there-upon and thenceforth become and be absolutely vested in and shall and may from time to time be exercised by the Bishop of Lichfield for the time being " being.'

Bristol (in witness whereof he has signed this Scheme) have prepared and now humbly lay before Your Majesty in Council the following Scheme for effecting the union of the benefice and ecclesiastical parish of Malmesbury and the benefice and ecclesiastical parish of Westport, Saint Mary, both situate in the county of Wilts and in the diocese of Bristol.

" SCHEME

"1. Union of Benefices and Parishes. The said benefice of Malmesbury and the said benefice of Westport, Saint Mary, shall be permanently united together and form one benefice with cure of souls under the style of 'The United Benefice of Malmes-bury with Westport, Saint Mary,' and the parishes of the said benefices shall also be united into one parish for ecclesiastical purposes. "2. Parish Church. The parish church of the parish of Malmesbury shall be the parish church of the united benefice. "3. Appropriation of Saint Mary's Church, West-

the united benefice. "3. Appropriation of Saint Mary's Church, West-port. After the union has taken effect the Church of Saint Mary, Westport, shall be appropriated as a Church room or parish hall in connexion with the united benefice and be used for such educational, charitable, or other purposes in connexion with the Church of England having in view the spiritual, intellectual, moral or social welfare of the parishioners of the parish of the said benefice and others and subject to such conditions, regulations and provisions as the Bishop of Bristol shall by Deed made pursuant to the 24th Section of the Union of Benefices Measure, 1923, declare and appoint; Pro-Benefices Measure, 1923, declare and appoint; Pro-vided always that the appropriation as aforesaid shall not take effect until the consents and approval which by the said Union of Benefices Measures are made requisite to the appropriation of any church under the powers conferred by those Measures shall

under the powers conterred by those Measures shall have been obtained. "4. Taking effect of union. Upon the day when any Order of Your Majesty in Council affirming this Scheme is published in the London Gazette the union shall forthwith take effect and the Reverend Arthur Beaghen if he is then incumbent of the said bene-fice of Malmesbury shall with his consent (testified by his signature hereto) be the first incumbent of the united benefice

by his signature hereto) be the first incumbent of the united benefice. "5. Registers. Upon the union taking effect the marriage registers in duplicate current at the church of Saint Mary, Westport, shall be sent by the in-cumbent of the united benefice to the Registrar General to be closed officially. "6. Parsonage House. Upon the union taking effect the parsonage house at present belonging to the benefice of Westport, Saint Mary, shall be the house of residence of the incumbent of the united benefice.

benefice. "7. Patronage. The patronage of the united benefice shall belong to the present patrons (being one and the same body) of the said two benefices." And whereas the provisions of the Union of Bene-fices Measures, 1923 to 1936, and the Union of Benefices Rules, 1926 to 1930, relating to the preparation and submission of this Scheme have been duly complied with: And whereas the said Scheme has been approved by His Majesty in Council: Now, therefore, His Majesty by and with the adfirm the said Scheme and to order that it shall be and become effectual in law immediately upon the
