1. The Lords Commissioners of His Majesty's Treasury hereby give notice that Tenders will be received at the Chief Cashier's Office, at the Bank of England on Friday, the 14th March, 1947, at 1 p.m., for Treasury Bills to be issued under the Treasury Bills Act, 1877, the National Debt Act, 1889, the National Loans Act, 1939, and the Miscellaneous Financial Provisions Act, 1946, to the amount of £170,000,000.

2. The Bills will be in amounts of £5,000, £10,000, £25,000, £50,000 or £100,000. They will be dated at the option of the tenderer on any business day from Monday, the 17th March, 1947, to Saturday, the 22nd March, 1947, inclusive, and will be payable at three months after date.

3. The Bills will be issued and paid at the Bank of England.

4. Each Tender must be for an amount not less than £50,000 and must specify the date on which the Bills required are to be dated, and the net amount per cent. (being an even multiple of one penny) which will be given for the amount applied for. Separate Tenders must be lodged for Bills of different dates.

## TRUNK ROADS ACT, 1930. SECTION 46.

## TRUNK ROADS ACT, 1946.

The Minister of Transport hereby gives notice that he proposes to make an Order under section 1 of the Trunk Roads Act, 1946, the effect of which will be:—

(a) that a new road which he proposes to construct at Guyhirn in the County of the Isle of Ely, will become a trunk road on the date when the Order comes into force in substitution for a length of approximately 1,925 yards of the Birmingham-Great Yarmouth Trunk Road at Guyhirn aforesaid and the length of the said Trunk Road superseded thereby will cease to be a trunk road on the first day of April next after the date on which notice is given by the Minister to the Isle of Ely County Council (who will thereafter become the highway authority responsible for that road) that the new road is opened for through traffic.

(b) to provide for the construction of a bridge carrying the new road over the navigable waters of the River Nene.
