WHEREAS His Majesty, in pursuance of the Regency Acts, 1937 and 1943, was pleased, by Letters Patent dated the 24th day of January, 1947, to delegate and grant unto His Royal Highness The Duke of Gloucester, K.G., K.T., K.P., G.M.B., G.C.M.G., G.C.V.O., Her Royal Highness The Princess Royal, G.C.V.O., G.B.E., C.I., and Viscount Lascelles, or any two of them, as Counsellors of State, full power and authority during the period of His Majesty's absence from the United Kingdom to summon and hold on His Majesty's behalf His Privy Council and to signify thereat His Majesty's approval of any matter or thing to which His Majesty's approval in Council is required:

And whereas the Ecclesiastical Commissioners for England have duly prepared and laid before His Majesty in Council a Scheme bearing date the 13th day of March, 1947, in the words and figures following, that is to say:—

"We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the 33rd and 34th years of Her late Majesty Queen Victoria, Chapter 39, and of the Acts therein mentioned, that is to say, the Act of the 3rd and 4th years of Her said late Majesty, Chapter 113, the Act of the 4th and 5th years of Her said late Majesty, Chapter 39, and the Act of the 31st and 32nd years of Her said late Majesty, Chapter 114, have prepared the following Scheme for effecting a transfer of the ownership of the advowson or perpetual right of patronage of and presentation to the church and cure (hereinafter called 'the said benefice') of Aythorpe Roding in the county of Essex and in the diocese of Chelmsford:

"Whereas we are satisfied that the Right Reverend Henry, now Bishop of Chelmsford, in his private capacity, is the patron or person entitled to present or nominate to the said benefice in case the same were now vacant and that the transfer (as hereinafter recommended and proposed) will tend to make better provision for the cure of souls:

"And whereas the said Henry, Bishop of Chelmsford, desires to transfer the advowson of the said benefice to the Bishop of Chelmsford for the time being of the said diocese and in evidence thereof and in token of his consent as Bishop of the said diocese has executed the same:

Now, therefore, we, the said Ecclesiastical Commissioners for England, humbly recommend and propose that, upon and from the day of the date of the publication in the London Gazette of any Order of Your Majesty in Council ratifying this Scheme and without any conveyance or assurance in the

law other than such duly gazetted Order, the whole advowson or perpetual right of patronage of and presentation to the said benefice shall be transferred to the said Henry, Bishop of Chelmsford, and his successors in the same Bishopric and shall thereupon and thenceforth become and be absolutely vested in and shall and may, from time to time, be exercised by the Bishop of Chelmsford for the time being.'

And whereas the said Scheme has been approved at the Council held under the authority of the said Letters Patent:

Now, therefore, His Royal Highness The Duke of Gloucester and Viscount Lascelles being authorised thereto by the said Letters Patent, have taken the said Scheme into consideration, and do hereby, by and with the advice of His Majesty's Privy Council, on His Majesty's behalf ratify the said Scheme and order and direct that the same and every part thereof shall be effectual in law immediately upon the publication of this Order in the London Gazette pursuant to the said Acts:

And do hereby, by and with the like advice, direct that this Order be forthwith registered by the Registrar of the said Diocese of Chelmsford.

WHEREAS His Majesty, in pursuance of the Regency Acts, 1937 and 1943, was pleased, by Letters Patent dated the 24th day of January, 1947, to delegate and grant unto His Royal Highness The Duke of Gloucester, K.G., K.T., K.P., G.M.B., G.C.M.G., G.C.V.O., Her Royal Highness The Princess Royal, G.C.V.O., G.B.E., C.I., and Viscount Lascelles, or any two of them, as Counsellors of State, full power and authority during the period of His Majesty's absence from the United Kingdom to summon and hold on His Majesty's behalf his Privy Council and to signify thereat His Majesty's approval of any matter or thing to which His Majesty's approval in Council is required:

And whereas the Ecclesiastical Commissioners for England have duly prepared and laid before His Majesty in Council a Scheme bearing date the 9th day of January, 1947, in the words and figures following, that is to say:

"We, the Ecclesiastical Commissioners for England, acting in pursuance of the Union of Benefices Measures, 1923 to 1936, and with the consent of the Right Reverend Ernest William, Bishop of Birmingham (in testimony whereof he has signed this Scheme), have prepared and now humbly lay before Your Majesty in Council the following

Scheme for effecting the union of the benefice and parish of Birmingham, Saint Paul, and the benefice and parish of Birmingham, Saint Mark, both situate in the diocese of Birmingham:

" SCHEME

" 1. *Union of Benefices and Parishes.* The said benefice of Birmingham, Saint Paul, and the said benefice of Birmingham, Saint Mark, shall be permanently united together and form one benefice with cure of souls under the style of 'The United Benefice of Birmingham, Saint Paul and Saint Mark' and the parishes of the said benefices shall also be united into one parish for ecclesiastical purposes.

" 2. *Taking effect of union.* Upon the day when any Order of Your Majesty in Council affirming this Scheme is published in the London Gazette the union shall forthwith take effect.

" 3. *Parish Church.* The Parish Church of the parish of Saint Paul, Birmingham, shall be the parish church of the united parish.

" 4. *Registers.* The marriage registers in duplicate current at the Church of Saint Mark, Birmingham, shall be sent by the incumbent of the united benefice to the Registrar General to be closed officially.

" 5. *Parsonage House.* The parsonage house at present belonging to the benefice of Birmingham, Saint Paul, shall be the house of residence of the incumbent of the united benefice.

" 6. *Patronage.* With the consents of the said Ernest William Bishop of Birmingham, the Reverend Travers Guy Rogers, of The Rectory, 6, Sir Harry's Road, Edgbaston, Birmingham, Canon of Birmingham Cathedral and Francis Henry Viney, of Compton Knowle, Birmingham, Esquire, being the patrons of the said benefice of Birmingham, Saint Mark (in testimony whereof they have signed this Scheme), the patronage of the said benefice of Birmingham, Saint Mark, shall be surrendered to the patrons of the said benefice of Birmingham, Saint Paul, to the intent that the patronage of the united benefice shall belong wholly to the patrons of the said benefice of Birmingham, Saint Paul.

" 7. *Demolition of the Church of Saint Mark.*

(a) As soon as conveniently may be after the union has taken effect the Church of Saint Mark, Birmingham, shall be taken down and the materials and site thereof, together with any ground annexed thereto and necessary for the use and enjoyment thereof shall be sold and disposed of by us, the said Ecclesiastical Commissioners, at such time or times and in such manner in all respects as to us shall seem expedient subject to the conditions and restrictions imposed by the said Measure. (b) The net proceeds to arise from such sale or sales after payment of the expenses attendant upon the sale or sales, the taking down of the Church, the removal of monuments (if any) and all other expenses incidental to these matters, shall be applied by us, the said Ecclesiastical Commissioners as follows, that is to say—(1) in payment of the compensation or compensations hereinafter mentioned or in repayment of any advance made for the purpose of such compensation or compensations; (2) as to such amount and in such proportions as we, the said Ecclesiastical Commissioners, after consultation with the Bishop of Birmingham for the time being, may decide for the benefit of the united benefice and any other benefice or benefices within the diocese of Birmingham; and (3) the residue (if any), of such net proceeds shall be added to the Expenses Fund established for the said diocese pursuant to Section 32 of the Union of Benefices Measure, 1923. (c) The font, communion table, and plate used for the purpose of the Holy Communion in the said Church of Saint Mark, Birmingham, shall not be sold but shall in accordance with the provisions of the said Measures and as the Bishop of the diocese may direct be transferred to the Church of Saint Paul, Birmingham, being the parish Church of the United Benefice or to some other Church or Churches within the said diocese of Birmingham, and the bells, organ and other furniture and fittings of the said Church of Saint Mark, Birmingham, or such of them as the Bishop of Birmingham shall select, shall be removed to the parish church of the united benefice or to any other church or chapel or churches or chapels within the diocese of Birmingham which the Bishop may select or shall be sold and in such case the proceeds shall be added to the fund arising from the sale of the site and materials of the said Church of Saint Mark, Birmingham, as aforesaid. (d) In the event of the services of any Church officers and servants of the said Church of Saint Mark, Birmingham, being dispensed with by reason of the union taking effect,

such Church officers and servants shall out of any moneys to be received by us, the said Ecclesiastical Commissioners, under the provisions of this clause receive such reasonable compensation as having regard to age, length of service, and other circumstances of the case shall seem to us and to the Bishop of Birmingham equitable and proper; Provided always that it shall be lawful for us if we shall see fit so to do in all or any of these cases, to advance the compensation money or any part thereof out of the said Expenses Fund.

" 8. *Provision of Clerical or Lay Assistance.* Upon the union taking effect the incumbent of the united benefice shall employ such whole or part-time clerical or lay assistance as the Bishop of Birmingham may from time to time direct and a part of the endowment of the united benefice that is to say an annual sum of £220 being part of a larger annual sum at present paid by us, the said Ecclesiastical Commissioners, to the incumbent for the time being of the said benefice of Birmingham, Saint Mark, shall be appropriated by us as a fund towards the cost of such assistance—and the said annual sum of £220 shall be paid by us to the Diocesan Board of Finance of the diocese upon trust to apply the same to the purpose aforesaid."

And whereas the provisions of the Union of Benefices Measures, 1923 to 1936, and the Union of Benefices Rules, 1926 to 1930, relating to the preparation and submission of this Scheme have been duly complied with:

And whereas the said Scheme has been approved at the Council held under the authority of the said Letters Patent:

Now, therefore, His Royal Highness The Duke of Gloucester and Viscount Lascelles being authorised thereto by the said Letters Patent, have taken the said Scheme into consideration, and do hereby, by and with the advice of His Majesty's Privy Council, on His Majesty's behalf affirm the said Scheme and order that it shall be and become effectual in law immediately upon the publication of this Order in the London Gazette.

TENDERS FOR TREASURY BILLS.

1. The Lords Commissioners of His Majesty's Treasury hereby give notice that Tenders will be received at the Chief Cashier's Office, at the Bank of England on Friday the 18th April, 1947, at 1 p.m., for Treasury Bills to be issued under the Treasury Bills Act, 1877, the National Debt Act, 1889, the National Loans Act, 1939, and the Miscellaneous Financial Provisions Act, 1946, to the amount of £170,000,000.

2. The Bills will be in amounts of £5,000, £10,000, £25,000, £50,000 or £100,000. They will be dated at the option of the tenderer on any business day from Monday, the 21st April, 1947, to Saturday, the 26th April, 1947, inclusive, and will be payable at three months after date.

3. The Bills will be issued and paid at the Bank of England.

(being an even multiple of one penny) which will be given for the amount applied for. Separate Tenders must be lodged for Bills of different dates.

5. Tenders must be made through a London Banker, Discount House or Broker.

The persons whose Tenders are accepted will be informed of the same not later than the following day and payment in full of the amounts of the accepted Tenders must be made to the Bank of England by means of Cash or a Banker's Draft on the Bank of England not later than 1.30 p.m. (Saturday 12 noon) on the day on which the relative Bills are to be dated.

7. Members of the House of Commons are not precluded from tendering for these Bills.

8. Tenders must be made on the printed forms which may be obtained from the Chief Cashier's Office, Bank of England.
