SPECIAL ENACTMENTS (EXTENSION OF TIME) ACT. 1940.

Whereas by section 10 of the Kingston-upon-Hull Corporation Act, 1933 (hereinafter called "the local Act") the Lord Mayor, Aldermen, and Citizens of the City and County of Kingston-upon-Hull (hereinafter called "the Corporation") are authorised to construct certain waterworks numbered respectively 1, 2 and 10. that is to say:

Work No. 1. A reservoir (to be called the "Farndale reservoir") to be situate in the parishes of Farndale East Side and Farndale West Side in the rural district of Kirbymoorside and to be formed by means of an embankment across

Work No. 2. An aqueduct to be situate in the said parish of Farndale West Side commencing in the river Dove and terminating at the commencement of Work No. 10;

Work No. 10. An aqueduct to be situate in the rural districts of Kirbymoorside Pickering Malton Norton Driffield and Beverley the urban districts of Malton Norton and Haltemprice and the borough of Beverley commencing at the termination of Work No. 2 and terminating in the Keldgate service reservoir of the Corporation.

And whereas the period limited by section 14 of the local Act for the completion of the said works was extended by the Minister of Health (hereinafter called "the Minister") by the Kingston-upon-Hull (Extension of Time) Order (No. 2) 1945 by three years, that is to say, until the thirty-first day of December, 1948;

And whereas the Conporation have made applica-tion to the Minister for an Order under the Special Enactments (Extension of Time) Act, 1940, to extend the time as now limited until the 30th June, 1950.
