"Now, therefore, we, the said Ecclesiastical Commissioners, with the consents of the Right Reverend Bertram, Bishop of Southwark, and of the Reverend William Gordon Acheson, the incumbent of the benefice of Saint Stephen, Lewisham (testified by their respectively signing this Soheme), do humbly recommend and propose to Your Majesty that so soon as conveniently may be after the publication in the London Gazette of any Order of Your Majesty in Council affirming this Scheme the said Church of the Transfiguration, Lewisham, shall, subject to the provisions of the said Measures, be appropriated for any educational, charitable or other purposes in connection with the Church of England having in view the spiritual, intellectual, moral or social welfare of the parishioners of the said parish of Saint Stephen, Lewisham, and others or be appropriated either exclusively or in conjunction with any such purposes as aforesaid for use or occupation by any diocesan body or organisation or otherwise for the furtherance of the work of the Church of England and subject to such conditions, regulations and provisions as the Bishon of Southwark shall by deed made nursuant of the work of the Church of England and subject to such conditions, regulations and provisions as the Bishop of Southwark shall by deed made pursuant to the 24th Section of the Union of Benefices Measure, 1923, declare and appoint."

"We, the Ecclesiastical Commissioners for England, acting in pursuance of the Union of Benefices Measures, 1923 to 1936, now humbly lay before Your Majesty in Council the following Scheme, which we have prepared, with the consent of the Right Reverend Joseph Wellington, Bishop of Truro (in witness whereof he has signed this Scheme), for effecting the union of the benefice of Saint Mellion and the benefice of Pillaton both situated in the

for effecting the union of the benefice of Saint Mellion and the benefice of Pillaton both situated in the Diocese of Truro.

"SCHEME.

"I. Union of Benefices.—The benefice of Saint Mellion and the benefice of Pillaton shall be permanently united together and form one benefice with cure of souls under the style of 'The United Benefice of Saint Mellion with Pillaton,' but the parishes of the said benefices shall continue in all respects

distinct.

"2. Taking effect of Union.—If upon the day when any Order of Your Majesty in Council ratifying this Scheme is published in the London Gazette—

(a) both benefices are vacant, the union shall

forthwith take effect;

(b) the benefice of Pillaton only is vacant, the union shall take effect upon the avoidance of the benefice of Saint Mellion occurring next after the

said day;
(c) the benefice of Saint Mellion only 's vacant,
the union shall forthwith take effect if the incumbent
of the benefice of Pillaton consents and the Bishop

approves;

(d) neither benefice is vacant, the union shall take effect upon the avoidance of the benefice of Saint Mellion occurring next after the said day, if the incumbent of the benefice of Pillaton consents and

the Bishop approves;
"Provided that in any case where the taking effect of the union is conditional upon the consent of the incumbent of the benefice of Pillaton and the approval of the Bishop and that consent or that approval is not given, the union shall then take effect upon the next avoidance of the benefice of

effect upon the next avoidance of the benefice of Pillaton.

"3. Parsonage House.—The parsonage house at present belonging to the benefice of Saint Mellion shall be the house of residence of the united benefice.

"4. Patronage.—After the union has taken effect the right of presentation to the united benefice shall be exercised by the patrons of the two benefices alternately, the patron of the benefice of Saint Mellion having the first presentation to the united benefice to be made after the union."
