"And whereas there is not at present a parsonage house belonging to either of the said benefices:

"Now, therefore, we, the said Ecclesiastical Commissioners for England, with the consent of the

"3. Parish Church.

The Parish Church of the parish of Foxholes shall be the parish church of the

"4. Registers. The marriage registers in duplicate current at the Church of Butterwick shall be sent by the incumbent of the united benefice to the Registrar General to be closed officially.

"5. Patronage. The patronage of the united benefice shall belong wholly to the patrons of the said benefice of Foxholes."

Blackawton.—Forthwith and entirely in the churchyard of the Parish Church of Saint Michael and All Angels, Blackawton:

Provided that-

(a) In any vault or walled grave now existing in the said Churchyard, burial may be allowed subject to the condition that every coffin buried in such vault or grave be separately en-closed by stonework or brickwork properly cemented.

(b) In any earthen grave now existing in the said Churchyard, the burial may be allowed of the body of any member of the family of the person or persons heretofore buried in such grave, subject to the condition that no part of the coffin containing the body shall be at a depth less than three feet below the level of

the surface of the ground adjoining the grave.

(c) In the said Churchyard, in any grave space in which no interment has heretofore taken in which no interment has heretorore taken place, the burial may be allowed of the body of any person for whom or of any member of a family for which such grave space has been reserved and appropriated as a burial place, with the exclusive right of burial therein, subject to the condition that no part of the coffin containing the body shall be at a depth less than three feet below the level of the surface of the ground adjoining the grave.
