Temporary (Reconstruction) Regulations for Filling Vacancies for Professional FILLING VACANCIES FOR PROFESSI ACCOUNTANTS IN GOVERNMENT DEPARTMENTS.

r. Both men and women may compete under these Regulations, but women will not be eligible for appointment to the War Office.

2. Every candidate must have been born on or after 2nd August, 1905, and have attained the age of 25 by the 1st January of the year in which he or she competes.

3. Candidates must be British subjects. They must also satisfy one of the following conditions:

(a) if natural-born British subjects, they must

either

(i) have at least one parent who is or was at

death a British subject; or

(ii) have resided in His Majesty's dominions and/or been employed elsewhere in the service of the Crown for at least five years out of the last eight years preceding the date of their appointment;
(b) if naturalised British subjects, they must

(b) if naturalised British subjects, they must have resided in His Majesty's dominions and/or been employed elsewhere in the service of the Crown for at least five years out of the last eight years preceding the date of their appointment.

(c) if not qualified under (a) or (b) of this paragraph they must satisfy the Commissioners that they are so closely connected with His Majesty's dominions either by ancestry, upbringing or residence, or by reason of National Service, that an exception may properly be made in their favour. Provided that a candidate will not be elicible for

Provided that a candidate will not be eligible for an appointment under the Admiralty, War Office or Ministry of Supply unless he or she is a natural born British subject and born within the United Kingdom or in one of the self-governing Dominions of parents also born within the United Kingdom or in one of the also born within the United Kingdom or in one of the self-governing Dominions, except when the circumstances are such as to justify a departure from the general rule, in which case, provided the candidate satisfies the conditions prescribed by the preceding paragraphs, he or she may be admitted to appointment or competition by special permission of the First Lord of the Admiralty, Secretary of State for War or Minister of Supply, as the case may be.
