RUBBER RECLAMATION WAGES COUNCIL (GREAT BRITAIN).

The Rubber Reclamation Wages Council, (Great Britain) hereby gives notice of its intention to submit to the Minister of Labour and National Service proposals for (1) the revocation of Order R.R.(16) dated 13th February, 1945, and for the fixing of specified statutory minimum remuneration in substitution for the minimum rates of wages at present in operation and (2) for the revocation of Order R.R.(6) dated 10th June, 1940, varied by Order R.R.(16) which relates to holidays with pay, and for the making of a wages regulation order with respect to holidays and holiday remuneration in substitution for the provisions at present in operation. for the provisions at present in operation.
