SUPPLIES AND SERVICES (TRANSITIONAL POWERS).

QUARRIES.

The Minister of Fuel and Power gives notice that on the 18th June, 1947, he made an Order under Regulation 59 of the Defence (General) Regulations, 1939, as having effect by virtue of the Supplies and Services (Transitional Powers) Act, 1945, exempt-ing quarries at which electric power is used from the requirements, regarding the construction of cables and other apparatus, in the Quarries General Regulations 1938 (No. 1233) as amended by the Quarries General Regulations (Electricity) 1945 (S.R. & O. 1945 No. 1350) so far as concerns the application of these requirements to cables and other apparatus which were in use before the 1st July, 1938.
