

## SCHEDULE.

## REGULATIONS.

1. *Objects.* The objects of the Corps shall be,
  - (a) to promote and encourage among young men a practical interest in aviation and to fit them to serve their country in Our Air Force, its reserves and auxiliaries, and also in the Air Branch of Our Navy or in Our Army;
  - (b) to provide training which will be useful both in the Air Services and in civil life;
  - (c) to foster the spirit of adventure, to promote sports and pastimes in healthy rivalry and to develop the qualities of mind and body which go to the making of a leader and a good citizen.
2. *Composition.* The Corps shall comprise squadrons and flights formed on a school or local basis and known as school or local squadrons or flights, also squadrons formed at certain universities when these are not squadrons of Our Air Force Volunteer Reserve.
3. *Formation of units.* Units of the Corps shall be formed under such conditions as to approval and otherwise as may be directed by Our Air Council.
4. *Commissioning of officers.* The officers appointed to the Corps shall hold commissions as officers in the Training Branch of Our Air Force Volunteer Reserve and shall be governed by the Regulations prescribed for that Reserve, in so far as the same are applicable to them and subject to such modification as Our Air Council may direct.
5. *Tenure of commissions.* Officers appointed to the Corps shall continue to hold commissions and to retain their rank only so long as they shall continue to serve as officers in the Corps, such commissions being terminated when Our Air Council shall decide that the services of the said officers are no longer required, or when the said officers shall be no longer actively employed with the Corps.
6. *Financial benefits.* Members of the Corps shall not be entitled to any pay, allowances and other benefits except as may be expressly provided in regulations made by Our Air Council.
7. *Air Council regulations.* It shall be competent for Our Air Council, subject to the conditions stated in this Our Warrant, to make regulations as to the constitution, organisation, training, discipline, conditions of service and of efficiency, allowances and grants, and all other matters affecting the Corps.
