At the Court at *Buckingham Palace*, the 25th day of July, 1947.

PRESENT,

The KING's Most Excellent Majesty in Council.

WHEREAS the Ecclesiastical Commissioners for England have in pursuance of the Union of Benefices Measures, 1923 to 1936, duly prepared and laid before His Majesty in Council a Scheme bearing date the 26th day of June, 1947, in the words and figures following, that is to say:

"We, the Ecclesiastical Commissioners for England, acting in pursuance of the Union of Benefices Measures, 1923 to 1936, and with the consent of the Right Reverend Richard, Bishop of Hereford (in witness whereof he has signed this Scheme) have prepared and now humbly lay before Your Majesty in Council the following Scheme for effecting the disunion of the united benefice of Stoke Edith with Dormington and the union of (1) the benefice of Stoke Edith with the benefice of Tarrington and (2) the benefice of Dormington with the benefice of Mordiford and (3) a part of the said benefice of Mordiford with the benefice of Woolhope all of which benefices are situate in the county and diocese of Hereford.

"SCHEME.

"Whereas by an Order of His late Majesty King George the Fifth in Council dated the 1st day of November, 1928, and published in the London Gazette on the following day it is directed that the benefice of Stoke Edith and the benefice of Dormington should be permanently united together and form one benefice with cure of souls, but that the parishes of the said benefices should continue distinct in all respects:

"And whereas in pursuance of the said Order and in the events which have happened the union of the said benefices took effect upon the 18th day of November, 1929:

"Now, therefore, we, the said Ecclesiastical Commissioners, do humbly recommend and propose to Your Majesty as follows, that is to say:—

"1. *Disunion of the united benefice of Stoke Edith with Dormington.*

(1) The union of the benefice of Stoke Edith and the benefice of Dormington in the said united benefice of Stoke Edith with Dormington shall be dissolved and the said benefices of Stoke Edith and Dormington shall thereupon each become a separate benefice with cure of souls within the limits of its separate parish.

(2) The disunion of the said united benefice shall take effect upon the day when any Order of Your Majesty in Council affirming this Scheme is published in the London Gazette.

(3) The parsonage house at Dormington of the said united benefice including the site and appurtenances thereof and the grounds usually occupied and enjoyed therewith shall belong to the benefice of Dormington.

(4) The endowments and property of the said united benefice shall be divided and distributed as follows, that is to say, the endowments and the property specified in Part I of the Schedule hereto shall be assigned and annexed to the benefice of Stoke Edith and the endowments specified in Part II of the Schedule hereto shall, subject to the provisions of sub-clause (2) of clause 4 of this Scheme, be assigned and annexed to the benefice of Dormington.

(5) The patronage of each of the benefices of Stoke Edith and Dormington shall belong to the patron to whom it belonged immediately before the taking effect of the said union.

"2. *Union of the benefices of Stoke Edith and Tarrington.*

(1) The benefice of Stoke Edith and the benefice of Tarrington shall be permanently united together and form one benefice with cure of souls under the style of 'the United Benefice of Tarrington with Stoke Edith' and that such united benefice shall be included in and form part of the Rural Deanery of Ledbury but the parishes of the said benefices shall continue distinct in all respects.

(2) The union shall take effect upon the day when any Order of Your Majesty in Council affirming this Scheme is published in the London Gazette and the Reverend Cuthbert Arthur Lea-Wilson if he is then incumbent of the benefice of Tarrington shall with his consent (testified by his signature hereto) be the first incumbent of the united benefice of Tarrington with Stoke Edith.

(3) Upon the union taking effect the parsonage house at present belonging to the benefice of Tarrington shall be the house of residence of the incumbent of the united benefice.

(4) After the union has taken effect, the right of presentation to the united benefice shall belong wholly to the present patron (being one and the same person) of the benefices of Stoke Edith and Tarrington.

"3. *Union of the benefices of Dormington and Mordiford.*

(1) The benefice of Dormington and the benefice of Mordiford shall be permanently united together and form one benefice with cure of souls under the style of 'The United Benefice of Dormington with Mordiford,' and that such united benefice shall be included in and form part of the Rural Deanery of Hereford South but the parishes of the said benefices shall continue distinct in all respects.

(2) The union shall take effect upon the day when any Order of Your Majesty in Council affirming this Scheme is published in the London Gazette and the Reverend Erroll George Tyndall Simey if he is then incumbent of the benefice of Mordiford shall with his consent (testified by his signature hereto) be the first incumbent of the united benefice of Dormington with Mordiford.

(3) Upon the union taking effect the parsonage house at present belonging to the benefice of Dormington including the site and appurtenances thereof and the grounds usually occupied and enjoyed therewith shall be the house of residence for the incumbent of the united benefice.

(4) After the union has taken effect, in every series of three successive turns of presentation to be made to the united benefice the patron of the benefice of Dormington shall have the first turn and the patron of the benefice of Mordiford shall have the second and third turns.

"4. *Union of part of the united benefice of Dormington with Mordiford with the benefice of Woolhope.*

(1) With the consent (testified by his signing this Scheme) of the said Reverend Erroll George Tyndall Simey as the incumbent of the benefice of Mordiford, upon the day following the day when any Order of Your Majesty in Council affirming this Scheme is published in the London Gazette all that part of the parish of Mordiford which lies to the east of the line shown in red upon the map or plan annexed to this scheme and which is shown by the pink colour thereon shall be severed from the remaining part of that parish and from the united benefice of Dormington with Mordiford and united to the benefice and parish of Woolhope.

(2) Upon the union taking effect the endowments specified in Part III of the Schedule hereto shall be severed and diverted from the united benefice of Dormington with Mordiford and shall be assigned and annexed to the benefice of Woolhope.

(3) The patronage of the benefice of Woolhope shall not be affected by anything recommended and proposed in this Scheme.

" THE SCHEDULE.

" PART I.

" (Endowments and property of the united benefice of Stoke Edith with Dormington to be assigned and annexed to the benefice of Stoke Edith upon the disunion taking effect.)

(a) All the glebe lands now belonging to the united benefice of Stoke Edith with Dormington.

(b) A sum of £966 3s. 7d. £2½ per cent. Treasury Stock (1975-) now held by Queen Anne's Bounty on behalf of the united benefice of Stoke Edith with Dormington, or any varied investment representing the same Stock.

(c) Such part of the money appropriated by Queen Anne's Bounty to the united benefice of Stoke Edith with Dormington pursuant to the Tithe Act, 1936, as will produce £93 18s. 8d. per annum.

" PART II.

" (Endowments of the united benefice of Stoke Edith with Dormington to be assigned and annexed to the benefice of Dormington upon the disunion taking effect.)

(a) Sums of (i) £2,322 16s. 4d. £2½ per cent. Treasury Stock (1975-), (ii) £1,034 2s. 5d. £3 per cent. Redemption Stock (1986-96) and (iii) £918 5s. 0d. £3½ per cent. Conversion Stock (1961) all of which sums of Stock are now held by the Ecclesiastical Commissioners on behalf of the united benefice of Stoke Edith with Dormington, or any varied investment representing the same Stocks.

(b) Such part of the money appropriated by Queen Anne's Bounty to the united benefice of Stoke Edith with Dormington pursuant to the Tithe Act, 1936, as will produce £278 15s. 8d. per annum.

" PART III.

" (Endowments of the united benefice of Dormington with Mordiford to be assigned and annexed to the benefice of Woolhope upon the union of part of the benefice of Mordiford with the benefice of Woolhope taking effect).

Such part of the money appropriated by Queen Anne's Bounty to the united benefice of Dormington with Mordiford pursuant to the Tithe Act, 1936, as will produce £200 per annum."

And whereas the provisions of the Union of Benefices Measures, 1923 to 1936, and the Union of Benefices Rules, 1926 to 1930, relating to the preparation and submission of this Scheme have been duly complied with:

And whereas the said Scheme has been approved by His Majesty in Council:

Now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to affirm the

said Scheme and to order that it shall be and become effectual in Law immediately upon the publication of this Order in the London Gazette.

WHEREAS the Ecclesiastical Commissioners for England have in pursuance of the Union of Benefices Measures, 1923 to 1936, duly prepared and laid before His Majesty in Council a Scheme bearing date the 26th day of June, 1947, in the words and figures following, that is to say:

" We, the Ecclesiastical Commissioners for England, acting in pursuance of the Union of Benefices Measures, 1923 to 1936, have prepared and now humbly lay before Your Majesty in Council the following Scheme for the sale of the site of the former consecrated Church of Saint Luke in the united parish of Saint Bartholomew and Saint Luke, Bowling, and in the diocese of Bradford:

" SCHEME.

" Whereas in pursuance of an Order of Your Majesty in Council dated the 30th day of April, 1940, and published in the London Gazette on the 3rd day of the following month for uniting the benefices and the parishes of Bowling, Saint Bartholomew, and Bradford, Saint Luke, the said Church of Saint Luke became a chapel of ease to the parish church of the united parish:

" And whereas the said Church of Saint Luke, being then in a dangerous condition and having ceased to be used for purposes of Divine Service, has been demolished under the authority of a faculty, dated the 17th day of October, 1946, of the Consistory Court of the said diocese and the materials thereof have been sold:

" Now, therefore, we, the said Ecclesiastical Commissioners, with the consent of the Right Reverend Alfred, Bishop of Bradford (in testimony whereof he has signed this Scheme) do humbly recommend and propose to Your Majesty, as follows, that is to say:—

" 1. That the site of the said Church of Saint Luke and the ground annexed or belonging thereto (not being ground forming part of a churchyard which has been used for burials) shall be sold and disposed of by us, the said Ecclesiastical Commissioners, at such time or times and in such manner in all respects and subject to such conditions as we shall deem expedient.

" 2. That the net proceeds of the sale as aforesaid of the materials of the said Church after payment thereof of the cost of the said faculty, and of all costs and expenses in relation to the sale shall be paid to us, the said Ecclesiastical Commissioners.

" 3. That the net proceeds to arise from the sale by us as aforesaid of the said site after payment thereof of all costs and expenses in relation to such sale and to the carrying into effect of this Scheme shall, together with the net proceeds of the sale of the materials of the said Church, be constituted a fund the income of which shall be applicable to the repair of the parish church of the united parish of Bowling, Saint Bartholomew and Saint Luke; and the said fund shall be transferred by us to the Diocesan Board of Finance of the said diocese as trustees to apply it accordingly."

And whereas the provisions of the Union of Benefices Measures, 1923 to 1936, and the Union of Benefices Rules, 1926 to 1930, relating to the preparation and submission of this Scheme have been duly complied with:

And whereas the said Scheme has been approved by His Majesty in Council:

Now, therefore, His Majesty by and with the advice of His said Council is pleased hereby to affirm the said Scheme and to order that it shall be and become effectual in law immediately upon the publication of this Order in the London Gazette.

"We, the Ecclesiastical Commissioners for England, acting in pursuance of the New Parishes Measure, 1943, have prepared and now humbly lay before Your Majesty in Council the following Scheme for altering the boundaries of the parish of Saint James, Lower Darwen, and the parish of The Saviour, Blackburn, both in the county of Lancaster and in the diocese of Blackburn:

"Whereas we are satisfied that it is desirable that the boundaries of the said parishes should be altered in the manner hereinafter mentioned:

"And whereas the Bishop of the diocese consents to the proposed arrangements (in testimony whereof he has signed this Scheme):

"Now, therefore, we, the said Ecclesiastical Commissioners for England humbly recommend and propose that from and after the day of the date of the publication in the London Gazette of any Order of Your Majesty in Council ratifying this Scheme the boundaries of the said parish of Saint James, Lower Darwen, and of the said parish of The Saviour, Blackburn, shall be altered in the manner described in the Schedule and delineated on the map annexed to this Scheme.

"The Schedule to which the foregoing Scheme has reference.

"The territory (shown by the pink colour on the map) to be annexed to the said parish of The Saviour, Blackburn:—

"All that portion of the said parish of Saint James, Lower Darwen, which is bounded upon the north by the said parish of The Saviour, Blackburn, and upon the remaining sides, that is to say upon the south west, upon the south east, upon the east and upon the north east by an imaginary line commencing at a point in the middle of the London Midland and Scottish Railway on the boundary which divides the said parish of The Saviour, Blackburn, from the said parish of Saint James, Lower Darwen and extending thence south eastwards along the middle of the said railway to the Bridge which carries the approach road leading to Lower Hill Farm and extending thence to and then generally north eastwards along the middle of the said approach road (excluding Lower Hill Farm House and buildings) to its junction with the footpath running in a north westerly direction from the approach road leading to Higher Hill Farm and extending thence to and along the middle of the last mentioned footpath first south eastwards (crossing the last mentioned approach road) and then eastwards to a point where the said footpath meets the wall or fence which divides the close numbered 312 from the close numbered 313 and extending thence northwards along the last mentioned wall or fence to its junction with the footpath running from Higher Croft to Lytham Road and extending thence northwards to and along the middle of the last mentioned footpath to its junction with Lytham Road and extending thence first north westwards to and then north eastwards along the middle of the last mentioned road to its junction with Morecombe Crescent and extending thence north westwards to and along the middle of the last mentioned Crescent to its junction with Manxman Road and extending thence first north westwards to and then north eastwards along the middle of the last mentioned road to its junction with Roman Road and extending thence first to the middle of the last mentioned road and then north westwards along the middle of that road to its junction with the boundary which divides the said parish of Saint James, Lower Darwen from the said parish of The Saviour, Blackburn."

And whereas the provisions of the New Parishes Measure, 1943, relating to the preparation and submission of this Scheme have been duly complied with:

And whereas the said Scheme has been approved by His Majesty in Council:

Now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to ratify the said Scheme, and to order and direct that the same and every part thereof shall be effectual in law immediately upon the publication of this Order in the London Gazette pursuant to the said Measure.

"Whereas we are satisfied that it is desirable that the boundaries of the said parishes should be altered in the manner hereinafter mentioned:

"And whereas the See is now vacant but the late Bishop of the diocese consented to the proposed arrangements (in testimony whereof he signed this Scheme prior to the sealing thereof and to his resignation of the See):

"Now, therefore, we, the said Ecclesiastical Commissioners for England, humbly recommend and propose that from and after the day of the date of publication in the London Gazette of any Order of Your Majesty in Council ratifying this Scheme the boundaries of the said parishes shall be altered in the manner described in the Schedule and delineated on the map annexed to this Scheme:

"The Schedule to which the foregoing Scheme has reference.

"The territory (shown by the pink colour on the map) to be annexed to the said parish of Saint Paul, Kersal Moor:—

"All that portion of the said parish of Prestwich which is bounded upon the west by the parish of Saint Anne, Clifton, upon the south-west by the parish of Saint John the Evangelist, Pendlebury, upon the south by the parish of Saint Paul, Kersal Moor, upon the east and upon part of the north-east by the parish of Saint Gabriel, Prestwich, and upon the remaining sides that is to say, upon the north-west and upon the remaining part of the north-east by an imaginary line commencing at the junction of Myrtle Grove and Hilton Lane on the boundary which divides the said parish of Saint Gabriel, Prestwich, from the said parish of Prestwich and extending thence south-westwards along the middle of Hilton Lane to its junction with Sandy Lane and extending thence north-westwards to and along the middle of the last mentioned lane (crossing Butterstile Lane) to its junction with Lowther Road and extending thence first north-westwards to and then westwards along the middle of the last mentioned road, for a distance of 9 chains, to the eastern wall or fence of the close numbered 504, and extending thence northwards along the said wall or fence for a distance of eight yards to the wall or fence which divides the close numbered 342, from the close numbered 504, and extending thence first westwards and then generally in a south-westerly direction along the walls or fences which divide the closes numbered 342 and 341, from the closes numbered 504 and 505 for a distance of 15½ chains to the junction of the last mentioned walls or fences with the wall or fence which divides the close numbered 341 from the close numbered 524, and continuing in the same direction along the wall or fence which divides the close numbered 505 from the close numbered 524 for a distance of 6½ chains, to a point where the said wall or fence turns southward and extending thence south-westwards in a straight line crossing Carr Clough and the closes numbered 506, 523 and 522, to the eastern end of the wall or fence which divides the closes numbered 518, 518A and 521, from the close numbered 517, and extending thence along the last mentioned wall or fence for a distance of 4½ chains to its junction with the embankment of the River Irwell and extending thence in the same direction for a distance of 1 chain to a point in the middle of the said river upon the boundary which divides the said parish of Prestwich from the said parish of Saint Anne, Clifton."

Now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to ratify the said Scheme, and to order and direct that the same and every part thereof shall be effectual in law immediately upon the publication of this Order in the London Gazette pursuant to the said Acts.

And His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said Diocese of Ely.
