or corporate member of the Institution of Mechanical Engineers with appreciable electrical engineering experience and have a minimum of 3 years' apprenticeship plus 2 years' employment with an engineering concern of good standing and have there gained experience in electrical and mechanical engineering. Candidates for appointer

Candidates for appointment to posts of Assistant Engineer (Mechanical Engineering) in the Mimstry of Transport should have a professional qualification in mechanical engineering under sub-paragraph I (a) or (b) above and should have completed a recog-nised course of theoretical and technical training in mechanical and antomobile arguing and have nised course of theoretical and technical training in mechanical and automobile engineering and have experience of road vehicle design and construc-tion. Previous experience is also desirable in (i) the technical aspects of the is also desirable in (i) the technical aspects of treation regulation of traffic, (ii) the mechanism of traffic control signals, and (iii) the design and installation of street lighting systems, respectively.

Candidates for appointment to posts in the Ministry of Works will be required to furnish evi-dence of their apprenticeship and experience, especially experience either in the design and execution of major new works or in management and supervision of large maintenance works of mechanical and/or electrical engineering plant and installations. Experience closely related to the engineering equipment of public and factory build-ings is particularly desirable.

The Commissioners may summon to appear before a Selection Board all who are found to be before a Selection Board all who are found to be prima facie eligible, or may, if they see fit, summon only those whose qualifications and experience are considered to be specially suitable for the posts for which they are being considered. The Selection Board shall have power to give such preference to candidates born on or after 2nd August, 1910, as the Commissioners consider appropriate. The decision of the Commissioners shall be final.

9. Persons upon whose training for the occupa-tion of teacher public money has been spent cannot be appointed until the consent of the appropriate central education authority (e.g., the Ministry of Education, the Scottish Education Department, the Ministry of Education for Northern Ireland) has been notified to the Commissioners.

10. It will rest with the Commissioners to deternine the Department to which each successful candidate shall be assigned. In making the assign-ment the Commissioners will be guided by the requirements of the public service. Subject to this condition, the wishes of candidates will, where possible, be respected.

11. Any attempt on the part of candidates to enlist support for their applications through Members of Parliament or other influential persons, except as referees to be named by them in their application forms, will disqualify them for Appointment.
