## EXCHANGE CONTROL ACT, 1947.

*This Notice is one of an administrative series issued by the Bank of England to draw attention in convenient form to the law contained in the Act and Treasury Orders made thereunder, and (by virtue of powers delegated by H.M. Treasury under Section 37 of the Act) to give certain exemptions, permissions, consents, authorities and directions (including directions imposing certain requirements on bankers and others under Section 34 of the Act). It should be construed accordingly.*

### PREFACE TO E.C. SECURITIES NOTICES.

#### THE APPOINTED DAY.

1. The 1st October, 1947, has been appointed by order of H.M. Treasury as the day on which the Exchange Control Act, 1947, shall come into force.

#### REVOCATION OF CERTAIN PROVISIONS OF THE DEFENCE (FINANCE) REGULATIONS, 1939.

2. H.M. Treasury have revoked as from the 1st October, 1947, certain of the Defence (Finance) Regulations, 1939, including the following Regulations which relate particularly to securities:—

Regulations 2C, 3, 3A, 3B and 3BA.

3. In addition certain of the Defence (Finance) Regulations dealing with other aspects of exchange control have been revoked as from the 1st October, 1947. Particulars of these Regulations are given in the Preface to E.C. General Notices—mentioned in paragraph 6 (b) below.

4. Orders made by H.M. Treasury under Regulation 1 of the Defence (Finance) Regulations are no longer in force and returns of securities under the Regulation are not required as from the 1st October, 1947.

5. Regulation 2A of the Defence (Finance) Regulations has not been revoked. Directions and instructions given thereunder remain in force.

### ADMINISTRATION.

#### Notices.

6. Notices issued in connection with the administration of the Exchange Control Act will be in two series as follows:—

(a) Notices dealing with transactions relating to securities, numbered E.C. Securities 1—7. These Notices have been issued undated and are introduced by this Preface. They should be dated 1st October, 1947, and will become effective as from that date.

(b) Notices dealing with other aspects of exchange control, numbered E.C. General 1 and onwards. Information relating to these Notices is contained in a "Preface to E.C. General Notices" dated 1st October, 1947.

7. The following Notices concerning securities issued under the Defence (Finance) Regulations, 1939, are cancelled as from the 1st October, 1947:—

F.E. 20, 28, 96, 150, 151, 190, 191, 192, 200, 202 and 258.

Instructions to Appointed Agents (other than the Bank of England) dated the 20th October, 1942.

Instructions to Registrars and Others concerned with Registers of Securities, dated the 20th October, 1942.

Notice to Registrars and Company Secretaries, dated the 22nd October, 1943.

8. In addition F.E. 225 and F.E. 235 are cancelled.

#### ALTERATIONS TO THE INSTRUCTIONS CONTAINED IN E.C. SECURITIES NOTICES ALREADY ISSUED.

##### Form L.

9. For the time being Forms L (licence for sale and re-investment) may be issued only by the Bank of England. The conditions on which Forms L will normally be authorised are not changed.

10. In paragraph 3 (page 6) of PART III of Notice E.C. (Securities) 1 the words "which should be submitted to an Authorised Depository" in the first line and "In other cases" in the last line should be deleted.

11. PART II (Authorisation of Form L) of Notice E.C. (Securities) 4 should be deleted.

##### Form M.

12. The issue of Forms M is to be discontinued on the coming into force of the Exchange Control Act. Supplies of Forms M which have already been sent to banks and others for use under the Exchange Control Act should accordingly be destroyed.

13. Forms M issued under the Defence (Finance) Regulations, 1939, will, however, remain valid.

14. Banks and others who have received Notice E.C. (Securities) 1 should:—

(a) make appropriate deletions from paragraphs 7—11 (page 6) of PART III of that Notice.

(b) amend paragraph 20 (page 8) of PART III of that Notice by substituting the words "from the 18th June, 1941, to the 30th September, 1947, inclusive" in place of the words "on or after the 18th June, 1941".

(c) amend Appendix I to that Notice by deleting Form M from the list of new or revised forms.

15. PART III (Issue of Form M) of Notice E.C. (Securities) 4 should be deleted.

*Authorised Depositories.*

16. The following name should be added to the list of Authorised Depositories which is given in Appendix II to Notices E.C. (Securities) 1 and 6:—  
"Co-operative Wholesale Society Ltd., Bankers".

*Definition of the Scheduled Territories.*

17. The definition of the Scheduled Territories which is given in Appendix I to Notices E.C. (Securities) 1 and 6 should be amended by deleting the words "Egypt, the Sudan".

**DECLARATIONS 1 AND 2 IN FORM D.**

18. Banks, Registrars, Company Secretaries and others should note that members of the Stock Exchange, Dublin, or the Stock Exchange, Cork, and members in Eire of the Provincial Brokers' Stock Exchange or the Association of Stock and Share Dealers are now authorised to sign Declarations 1 and/or 2 in Form D in respect of dealings in securities registered in the United Kingdom.

**NON-ENEMY DECLARATIONS.**

19. The T.W.E.D. Notices to Banks relating to the collection of income and capital repayments on securities which are currently operative on the date of this Notice are No. 54 and the Notices referred to therein as remaining in force.

**TRANSITIONAL ARRANGEMENTS.**

*Transfers.*

20. Until the 1st November, 1947, Registrars may, in lieu of any corresponding requirement in E.C. Securities Notices, accept any declaration or authorisation dated prior to the 1st October, 1947, which has been given in accordance with the procedure detailed in F.E. 190 or the Instructions to Registrars and Others concerned with Registers of Securities, dated the 20th October, 1942.

21. Until the 31st December, 1947, Registrars may, in respect of transfers between residents in the Scheduled Territories which do not relate to Prescribed Securities, accept Declarations D.1 and D.2 as required under the Defence (Finance) Regulations, 1939, which are already printed on forms of transfer provided that they are signed by Authorised Depositories or Temporary Recipients.

*Permissions given under the Defence (Finance) Regulations, 1939.*

22. Permissions relating to securities given under the Defence (Finance) Regulations, 1939, in Forms K, L, M, S.6, S.8, S.10, S.11, and Certificates "C" which were in force immediately prior to the 1st October, 1947 are hereby continued as permissions given under the Act.

#### PETROLEUM (PRODUCTION) ACT, 1934.

In pursuance of Section 2 (3) of the Petroleum (Production) Act, 1934, the Minister of Fuel and Power gives notice that in accordance with the provisions of that Act and of the Petroleum (Production) Regulations, 1935, he had granted to the D'Arcy Exploration Company Limited, Britannic House, Finsbury Circus, London, E.C.2, a Mining Licence in respect of the area referred to in the Schedule hereto, the boundaries of which are described by reference to the one-inch Ordnance Survey map, supplemented where necessary by reference to the six-inch Ordnance Survey map.

The Civil Service Commissioners hereby give notice that the following Regulations are published with the approval of the Lords Commissioners of His Majesty's Treasury, viz.:—

TEMPORARY (RECONSTRUCTION) REGULATIONS FOR FILLING VACANCIES FOR MECHANICAL AND ELECTRICAL ENGINEERS (DEPARTMENTAL CLASS) IN THE MINISTRY OF SUPPLY.

1. Men and women may compete under these Regulations.

2. Every candidate must have been born on or after 2nd August, 1911, and have attained the age of 21 on the 1st January of the year in which he or she competes.

3. No person is eligible for employment in the Ministry of Supply who is not a natural-born British subject and born within the United Kingdom or in one of the self-governing Dominions of parents also born within the United Kingdom or in one of the self-governing Dominions.

No departure from this rule will be made without the special permission of the Minister of Supply, and then only in exceptional cases and in favour of candidates who are British subjects and who also satisfy one of the following conditions:—

(a) If natural-born British subjects, they must either

(i) have at least one parent who is or was at death a British subject; or

(ii) have resided in His Majesty's dominions and/or been employed elsewhere in the service of the Crown for at least five years out of the last eight years preceding the date of their appointment;

(b) If naturalized British subjects, they must have resided in His Majesty's dominions and/or been employed elsewhere in the service of the Crown for at least five years out of the last eight years preceding the date of their appointment.

(c) If not qualified under (a) or (b) of this paragraph they must satisfy the Commissioners that they are so closely connected with His Majesty's dominions either by ancestry, upbringing or residence, or by reason of national service, that an exception may properly be made in their favour.

4. Every candidate must have received a full and proper training as a mechanical and/or electrical engineer and will be required to state on his application form the nature of any particular engineering experience gained in the course of or after training.

Normally he or she must either have obtained or be eligible for corporate membership of one of the Institutions of Civil, Mechanical or Electrical Engineers or Associate Fellowship of the Royal Aeronautical Society. For the purpose of these Regulations eligibility for Corporate Membership (or Associate Fellowship of the R.Ae.S.) will be considered to include the following requirements:—

(a) An engineering apprenticeship or pupilage including a minimum period of two years in the workshops of a reputable establishment, and

(b) (i) an engineering degree of a British University, or

(ii) a Higher National Certificate in mechanical or electrical engineering, or

(iii) have passed examinations recognised by the above named professional Institutions as granting exemption from Parts A and B of the Associate Membership examinations or from the Associate Fellowship examination of the R.Ae.S.

It will be a condition of recruitment that confirmation of appointments will be dependent upon the candidate securing Corporate Membership of either one of the aforementioned professional engineering institutions or Associate Fellowship of the R.Ae.S. before the completion of his or her period of probationary service.

Exceptionally the Commissioners may at their discretion admit a candidate with high attainments and standing in the engineering profession without insisting on qualifications of the form above.

5.—(1) Every candidate must satisfy the Commissioners as to his or her health and character.

(2) The Commissioners reserve the right to give such preference to disabled persons or to particular classes of disabled persons as may be necessary in order to give effect to any general policy regarding the employment of such persons which may be adopted by His Majesty's Government, provided that the disability is not of a nature to interfere with the discharge of the duties required.

6. No person who is undergoing a course of study with the aid of a grant from public funds shall be eligible to compete before the completion of the course, unless he or she has previously obtained permission to do so from the authority which administers the grant.

7. Every candidate must apply on the appropriate form within the time and in the manner of which notice is given by the Commissioners.

8. Those candidates who on their Application Forms and the resulting enquiries are found to be *prima facie* eligible will be summoned to appear before a Selection Board appointed by the Commissioners; they may also be required to attend for a preliminary informal interview. The Selection Board shall have power to give such preference as they consider appropriate to candidates born on or after 2nd August, 1916, and candidates born before that date will be expected to have especially useful experience to their credit of a particular kind required by the Department. Subject to this preference the Selection Board will recommend for appointment those candidates who appear to them to possess the most appropriate qualifications, having regard to the nature of the vacancies available.

9. Candidates on whose training for the occupation of teacher public money has been spent cannot be appointed until the consent of the appropriate central education authority (e.g., the Ministry of Education, the Scottish Education Department, the Ministry of Education for Northern Ireland) has been notified to the Commissioners.

10. Any attempt on the part of candidates to enlist support for their applications through Members of Parliament or other influential persons, except as referees to be named by them in their Application Form, will disqualify them for appointment. The Interviewing Board will disregard recommendations from persons who are not personally acquainted with the candidate's work, whether at school, at the University, in the Forces, or otherwise.

11. Every candidate shall pay a fee of £1 before the issue of a certificate of qualification for appointment.
