LONDON TRAFFIC ACT, 1924.

Notice is hereby given under the Rules Publication Act, 1893, that it is proposed by the Minister of Transport after the expiry of at least 40 days from this date in pursuance of the powers conferred upon him by section 10 of the London Traffic Act,
