

the line turns Westward along the centre of Bride Lane to a point opposite the Western boundary of No. 14 Bride Lane where the line turns Northward and Eastward along the Western and Northern boundaries of No. 14 Bride Lane to a point where the Northern boundary of No. 14 Bride Lane joins the Northern boundary of No. 9 New Bridge Street where the line continues Eastward along the Southern boundary of Nos. 6/7 New Bridge Street and continues to a point in the centre of New Bridge Street where the line turns Northward along the centre of New Bridge Street and continues to a point in the centre of Ludgate Circus where the line turns Westward along the centre of Fleet Street to a point opposite the Eastern boundary of No. 121 Fleet Street where the line turns Northward along the Eastern boundaries of No. 121 Fleet Street and Nos. 1/8 Shoe Lane and the South-Western boundary of No. 23 St. Bride Street to the Southern boundary of No. 9 Shoe Lane where the line turns Westward along the Southern boundary of No. 9 Shoe Lane and continues to a point in the centre of Shoe Lane where the line turns Northward along the centre of Shoe Lane to a point opposite the centre of Wine Office Court where the line turns Westward and Southward along the centre of Wine Office Court to a point opposite the Northern boundary of No. 7 Wine Office Court where the line turns Westward along the Northern boundary of No. 7 Wine Office Court and the Southern boundary of No. 9 Gough Square and continues to a point in the centre of Gough Square opposite the Southern boundary of No. 9 Gough Square where the line turns Northward and Westward along the centre of the public way in Gough Square to a point opposite the centre of Johnson's Court where the line turns Southward and Westward along the centre of Johnson's Court to a point on that part of the Eastern boundary of No. 4 Johnson's Court immediately to the South of No. 11 Johnson's Court where the line turns Northward Westward and Southward along the Eastern Northern and Western boundaries of No. 4 Johnson's Court to the South-East corner of No. 9 Red Lion Court where the line turns Westward and Northward along the Southern and Western boundaries of No. 9 Red Lion Court where it continues Northward across Red Lion Court to the South-East corner of the Red Lion Public House where the line turns Westward along the Southern boundaries of The Red Lion Public House and No. 7 Crane Court and No. 14 Fleur-de-Lis Court and continues to a point in the centre of Fleur-de-Lis Court where the line turns Southward and Westward along the centre of Fleur-de-Lis Court and continues to a point in the centre of Fetter Lane where the line turns Northward along the centre of Fetter Lane to a point opposite the centre of Rolls Buildings where the line turns Westward along the centre of Rolls Buildings to a point on the City Boundary where the line turns Northward along the City Boundary to a point in the centre of Took's Court where the line turns Eastward along the centre of Took's Court to a point some 68 feet East of the City Boundary where the line turns Northward to the Patent Office where the line turns Eastward along the Southern boundary of the Patent Office and continues to a point in the centre of Furnival Street where the line turns Southward along the centre of Furnival Street to a point opposite the centre of Norwich Street where the line turns Eastward along the centre of Norwich Street and continues to a point in the centre of Fetter Lane where the line turns Northward along the centre of Fetter Lane to a point in Holborn on the City Boundary where the line closes.

Area No. 2.

The area is bounded by a line commencing on the City Boundary in the centre of Aldersgate Street and the line follows the City Boundary Eastward to a point in the centre of Whitecross Street where the line turns Southward and follows the centre of Whitecross Street to a point opposite the centre of Silk Street where the line turns Eastward along the centre of Silk Street and continues to a point in the centre of Milton Street where the line turns Northward along the centre of Milton Street to a point on the City Boundary where the line turns Eastward and follows the City Boundary to a point in Ropemaker Street opposite the centre of Moorfields where the line turns Southward along the centre of Moorfields and continues to a point in the centre of Fore Street where the line turns Westward and follows the centre of Fore Street to a point opposite the centre of Coleman Street where the line turns Southward and follows the centre of

Coleman Street to a point opposite the Northern boundary of No. 8 Coleman Street where the line turns Westward and Southward along the Northern and Western boundaries of No. 8 Coleman Street to a point in the centre of Basinghall Avenue where the line turns Westward and follows the centre of Basinghall Avenue to a point opposite the Western boundary of No. 9 Coleman Street where the line turns Southward along the Western boundaries of Nos. 9 and 10 Coleman Street and continues Southward to a point on the Northern boundary of No. 16 Coleman Street where the line turns Westward and follows the Northern boundary of No. 16 Coleman Street and continues Westward to the South-Eastern corner of No. 36 Basinghall Street where the line continues Westward and Southward along the Southern boundary of No. 36 Basinghall Street until it meets the Northern boundary of Nos. 32/33/34 Basinghall Street where it continues Southward and Westward and follows the Eastern and Southern boundaries of Nos. 32/33/34 Basinghall Street at ground level and continues Westward to a point in the centre of Basinghall Street where the line turns Southward and follows the centre of Basinghall Street to a point opposite the centre of Church Alley where the line follows the centre of Church Alley Westward and Northward to a point opposite the centre of Three Nun Court where the line continues Northward to the North-Western corner of the public way in Church Alley where the line continues Northward and Westward following the boundaries of Nos. 20/21 Aldermanbury and continues Westward to a point in the centre of Aldermanbury where the line turns Southward and follows the centre of Aldermanbury to a point opposite the Northern boundary of No. 17 Aldermanbury where the line turns Eastward and follows the Northern boundary of No. 17 Aldermanbury to a point on the boundary of the offices of the Corporation attached to Guildhall where the line turns Southward along the Western boundary of the offices attached to Guildhall and continues to a point in the centre of Church Passage where the line turns Westward and then Southward along the centre of Church Passage and continues to a point in the centre of Gresham Street where the line turns Eastward and follows the centre of Gresham Street to a point opposite the centre of Lawrence Lane where the line turns Southward along the centre of Lawrence Lane and continues to a point in the centre of Cheapside where the line turns Westward to a point in the centre of Cheapside opposite the Eastern boundary of No. 59 Cheapside where the line follows the Eastern and Southern boundaries of No. 59 Cheapside and continues Westward to a point in the centre of Bow Lane where the line turns Southward and follows the centre of Bow Lane to a point opposite the centre of Watling Street where the line turns Westward and follows the centre of Watling Street to a point opposite the centre of Watling Court where the line turns Southward and Eastward along the centre of Watling Court to a point opposite the Western boundary of No. 9 Watling Court where the line turns Southward along the Western boundaries at ground level of No. 9 Watling Court and Nos. 39/41 Cannon Street and continues to a point in the centre of Cannon Street where the line turns Eastward and describes an arc in a Southward direction to the North-West corner of No. 65 Queen Victoria Street where the line follows the Western boundary of No. 65 Queen Victoria Street Southward and continues to a point in the centre of Great Trinity Lane where the line turns Westward along the centre of Great Trinity Lane to a point opposite the centre of Little Trinity Lane where the line turns Southward and follows the centre of Little Trinity Lane to a point opposite the Northern boundary of No. 25 Little Trinity Lane where the line turns Eastward then Southward and follows the Northern and Eastern boundaries of Nos. 21/25 Little Trinity Lane and continues Southward to a point on the Northern boundary of No. 197 Upper Thames Street where it turns Eastward along the Northern Boundary of No. 197 Upper Thames Street and continues Eastward to a point in the centre of Sugar Loaf Court where it turns Northward and Eastward along the centre of Sugar Loaf Court to the Western end of that part of Sugar Loaf Court which connects with Garlick Hill under the upper part of No. 14 Garlick Hill where the line follows the Southern boundary of Nos. 5/13 Garlick Hill Eastward and continues to a point in the centre of Garlick Hill where the line turns Southward to a point in the centre of Garlick Hill opposite the centre of Skinners Lane where the line turns Eastward and follows the centre
