

follows the centre of Bucklersbury across Queen Victoria Street and continues Eastward to a point in Mansion House Yard opposite the centre of Walbrook where the line turns Southward along the centre of Walbrook to a point opposite the Northern boundary of No. 38, Walbrook where the line turns Eastward and Northward along the Southern and Eastern boundaries of the Church of St. Stephen Walbrook to the Southern boundary of the Churchyard where the line turns Eastward along the Southern boundary of the Churchyard for some 30 feet where the line turns Southward to a point on the Northern boundary of the buildings attached to the Salters' Hall where the line turns Eastward along the Northern boundaries of the buildings attached to the Salters' Hall and No. 10 St. Swithin's Lane and continues to a point in the centre of St. Swithin's Lane where the line turns Southward along the centre of St. Swithin's Lane to a point opposite to the Northern boundary of No. 15 St. Swithin's Lane where the line turns Westward along the Northern boundary of No. 15 St. Swithin's Lane to the Eastern boundary of No. 3 Salters' Hall Court where the line turns Southward and Westward along the Eastern and Southern boundaries of No. 3 Salters' Hall Court to the North-Western corner of Salters' Hall Court where the line turns North-North-Eastward for some 25 feet where the line turns West-North-Westward for a distance of some 50 feet where the line turns South-South-Westward for a distance of some 20 feet where the line turns West-North-Westward until it meets the Eastern boundary of No. 1 Oxford Court where the line follows the Eastern boundary of No. 1 Oxford Court Southward and crosses Oxford Court to a point on the Northern boundary of No. 103 Cannon Street where the line turns Westward along the Northern boundary of Nos. 97/103 Cannon Street to the North-Western corner of Nos. 97/101 Cannon Street where the line turns Southward along the Western boundary of Nos. 97/101 Cannon Street and continues to a point in the centre of Cannon Street where the line turns Westward along the centres of Cannon Street Budge Row and Watling Street and crosses Queen Victoria Street to a point in the centre of Queen Street where the line turns Northward along the centre of Queen Street to a point opposite the Southern boundary of No. 88 Queen Street where the line turns Eastward along the Southern boundary of No. 88 Queen Street to the boundary of No. 85 Queen Street where the line turns Northward and Eastward along the boundary of No. 85 Queen Street to the North-Eastern corner of No. 85 Queen Street where the line turns Northward and continues along the Eastern boundary of Nos. 90/93 Queen Street and Nos. 72/73 Cheapside and continues to a point in the centre of Cheapside where the line closes.

Area No. 4.

The area is bounded by a line commencing at a point in the centre of Leadenhall Street opposite the centre of Lime Street and the line proceeds Eastward along the centre of Leadenhall Street to a point opposite the centre of Billiter Street where the line turns Southward along the centre of Billiter Street and continues to a point in the centre of Fenchurch Street where the line turns Eastward along the centre of Fenchurch Street to a point opposite the centre of Railway Place where the line turns Southward then Westward and follows the centre of Railway Place and London Street and continues to a point in the centre of Mark Lane where the line turns Southward along the centre of Mark Lane to a point opposite the centre of Hart Street where the line turns Eastward along the centre of Hart Street and continues to a point opposite the centre of Seething Lane where the line turns Southward along the centre of Seething Lane to a point opposite the centre of Muscovy Street where the line turns Eastward along the centre of Muscovy Street to a point on the City Boundary in Trinity Square where the line turns Southward along the City Boundary to a point opposite the Southern boundary of Brewer's Quay where the line turns Westward to Brewer's Quay and continues along the Southern boundary of Brewer's Quay to the South-Western corner of Brewer's Quay where it crosses the mouth of Galley Dock where it turns Northward along the Western boundary of Galley Dock and Brewer's Quay and continues to a point in the centre of Lower Thames Street where the line turns Westward along the centre of Lower Thames Street to a point opposite the centre of St. Mary at Hill where the line turns Northward along the centre of St. Mary at Hill to a point

opposite the centre of St. Dunstan's Lane where the line turns Eastward along the centre of St. Dunstan's Lane and continues to a point in the centre of Idol Lane where the line follows the centre of Idol Lane Eastward and Southward and continues to a point in the centre of St. Dunstan's Hill where the line turns Eastward and Northward along the centre of St. Dunstan's Hill to a point opposite the centre of St. Dunstan's Alley where the line turns Westward along the centre of St. Dunstan's Alley to a point opposite the Western boundary of the site of Nos. 2/4/4a St. Dunstan's Alley and Nos. 5/10 Great Tower Street where the line turns Northward along the Western boundaries of the site of Nos. 2/4/4a St. Dunstan's Alley and Nos. 5/10 Great Tower Street and continues to a point in the centre of Great Tower Street where the line turns Westward along the centre of Great Tower Street and Eastcheap to a point opposite the Eastern boundary of No. 47 Eastcheap where the line turns Northward and Westward along the Eastern and Northern boundaries of No. 47 Eastcheap and the Eastern boundary of the Church of St. Margaret Patten to the North-Eastern corner of the Church of St. Margaret Patten where the line turns Eastward Northward and Eastward along the Southern boundary of Plantation House and continues Eastward to a point in the centre of Mincing Lane where the line turns Northward along the centre of Mincing Lane and continues to a point in the centre of Fenchurch Street where the line turns Westward along the centre of Fenchurch Street to a point opposite the centre of Cullum Street where the line turns Northward and Westward along the centre of Cullum Street to a point opposite the Western boundary of No. 4 Cullum Street where the line turns Northward and Eastward along the Western and Northern boundaries of No. 4 Cullum Street and continues Eastward to the Northern boundary of No. 6 Fen Court where the line follows the Northern boundary of No. 6 Fen Court and continues Eastward to a point in the centre of Fen Court where the line turns Northward along the centre of Fen Court and the Southern arm of Fenchurch Avenue and continues to a point opposite the centre of the Western arm of Fenchurch Avenue where the line turns Westward along the centre of the Western arm of Fenchurch Avenue and continues to a point in the centre of Lime Street where the line turns Northward along the centre of Lime Street and continues to a point in the centre of Leadenhall Street where the line closes.

Area No. 5.

The area is bounded by a line commencing in the centre of Houndsditch opposite the South-Eastern boundary of No. 76 Houndsditch and the line proceeds South-Eastward along the centre of Houndsditch to a point opposite the centre of Cavendish Court where the line turns North-Eastward along the centre of Cavendish Court to a point opposite the South-Western boundary of Devonshire Square where the line turns South-Eastward along the South-Western boundary of Devonshire Square to the North-Western boundary of No. 6 Devonshire Square where the line turns South-Westward along the North-Western boundary of No. 6 Devonshire Square to the Western corner of No. 6 Devonshire Square where the line turns South-Eastward along the South-Western boundary of No. 6 Devonshire Square to a point opposite the North-Western boundary of the George and Dragon Public House where the line turns South-Westward along the North-Western boundary of the George and Dragon Public House and continues to a point in the centre of Houndsditch where the line turns North-Westward along the centre of Houndsditch to a point opposite the North-Western boundary of No. 60 Houndsditch where the line turns South-Westward along the North-Western boundary of No. 60 Houndsditch to a point on the North-Eastern boundary of the St. Martin Outwich Churchyard where the line turns North-Westward and South-Westward along the North-Eastern and North-Western boundaries of the St. Martin Outwich Churchyard and continues to a point in the centre of Camomile Street where the line turns South-Eastward along the centre of Camomile Street and continues to a point in the centre of St. Mary Axe where the line turns South-Westward along the centre of St. Mary Axe to a point opposite the Southern boundary of No. 41 St. Mary Axe where the line turns Westward along the Southern boundary of No. 41 St. Mary Axe to the Eastern boundary of No. 13 St. Helen's Place where the line turns North-
