CONFIRMATION OF BYELAWS.

NOTICE is hereby given that the Urban District Council of Cromer intend to apply to the Minister of Health as soon as may be after the 23rd day of December 1947, for confirmation of Byelaws made by them under Section 17 of the Water Act, 1945, for preventing waste, undue consumption, misuse or contamination of water supplied by them.
