The Lords Commissioners of His Majesty's Treasury hereby give notice that They propose to make an Order under Section 20 of the Finance (No. 2) Act, 1940, to

(a) exempt from purchase tax domestic space heating appliances incorporating electric fans or electric pumps or both such fans and such pumps, designed to consume in all, not more than 100 watts, but not including appliances otherwise electrically operated and not including appliances operated by gas; and

(b) to take out of the intermediate rate (75 per cent.) those other space heating and water heating appliances which, although operating from electric or gas mains do not use electricity or gas as the source of heat. The pre-1947 Budget position of these appliances would then be restored, i.e. some would be chargeable at the basic rate (formerly 33½ per cent., now 50 per cent.), and some would be exempt.
