TREASURY MINUTE PRESCRIBING THE TERMS AND CONDITIONS UPON WHICH PREMATURE REPAYMENTS WHICH LOCAL AUTHORITIES RECEIVE FROM BORROWERS TO WHOM THEY HAVE MADE ADVANCES, BORROWERS TO WHOM THEY HAVE MADE ADVANCES, UNDER SECTION 91 OF THE HOUSING ACT, 1936, OR SECTION 75 OF THE HOUSING (SCOTLAND) ACT, 1925, AND SIMILAR ENACTMENTS, MAY BE ACCEPTED AT PAR BY THE PUBLIC WORKS LOAN COMMISSIONERS IN ADVANCE OF THE DUE DATES FIXED BY THE MORTGAGES SECURING THE RELATIVE LOANS MADE TO THE LOCAL AUTHORITIES FROM THE LOCAL LOANS FUND.

1. My Lords have had under further consideration the terms upon which repayments may be accepted by the Public Works Loan Commissioners in advance of the due date in respect of loans made to local authorities for the purposes of Section 91 of the Housing Act 1936, or Section 75 of the Housing (Scotland) Act 1925 and similar enactments.

2. My Lords conclude that it would now be appropriate to allow premature repayments in respect of such loans to be made on terms and conrespect of such loans to be made on terms and con-ditions similar to those governing the acceptance of premature repayments at par on account of loans under the Small Dwellings Acquisition Acts or the Small Dwellings Acquisition (Scotland) Acts.

3. They therefore direct that as from the date of this Minute, repayments in advance of the due date shall be accepted on the basis of from from advanced in respect of loans made for the purposes mentioned in paragraph 1 above, provided that at least one month's notice is given to the Public Works Loan Commissioners and provided that the sums to be repaid prematurely
(a) are sums which have been or are about to

be repaid prematurely at par to the local authorities by borrowers whose advances under the enactments mentioned in paragraph I were financed out of loans from the Public Works Loan Board, and

(b) are applied pro rata in discharge or reduction of the loans from the Public Works Loan Commissioners out of which the relative advances were financed by the local authority.

4. As from the date of this Minute paragraph 6 (b) of Treasury Minute dated 1st August 1945, shall cease to have effect.

EXPLANATORY NOTE

These Regulations contain provisions in regard to the payment and collection of contributions under the National Insurance Act, 1946, payable by insured persons and employers, either by means of adhesive stamps or under other arrangements, and in connection therewith provide for the issue, custody and surrender of insurance cards.

In relation to insured persons whose employers are liable to pay contributions on their behalf, provision is made governing both the recovery of such contributions from the insured persons and the discharge of the employer's liability in cases where there is more than one employer.
