The Civil Service Commissioners, with the approval of the Lords Commissioners of His Majesty's Treasury, hereby give notice of the following addition and amendments to the Temporary (Reconstruction) Regulations for filling vacancies for Assistant Engineers in the General Service Class of Mechanical and Electrical Engineers in Government Departments.

**ADDITION.**

(i) There will be two additional vacancies of Assistant Technical Officers in the Royal Mint to be filled through the open Reconstruction competition for Assistant Engineers in the general service class of mechanical and electrical engineers which is to be held under Regulations for that class as amended below.

(ii) Women are not eligible for appointment to these vacancies.

(iii) The Engineering and Metallurgical work which is under the control of the Technical Officers in the Royal Mint consists of the following:—

(a) Installation and maintenance of all machinery in the Department, including electrical plant, and the manufacture of certain machines, jigs, and tools incidental to coinage, medal and stamp plate processes.

(b) All melting operations including alloying, de-oxidising, care of moulds, crucibles, fuel, etc., treatment of recoveries and supervision of quality of cast metals.

(c) Supervision throughout of the processes of manufacture of coins, medals, dies, and stamp plates, including Rolling, Cutting, Annealing, Stamping and Electrotyping, maintenance of all standards of measurement and weight, responsibility for the quality of all finished work, and supervision of the operatives.

**AMENDMENTS.***Heading.*

Add "(including Assistant Technical Officers in the Royal Mint)".

*Regulation 1.*

Substitute:—"Men and women may compete under these Regulations except that women will not be eligible for appointments under the Air Ministry or as Assistant Technical Officer in the Royal Mint".

Add:—"Candidates for appointment to posts of Assistant Technical Officer in the Royal Mint must have a minimum of two years' practical experience in an engineering firm of good standing".
