TENDERS FOR TREASURY BILLS.

1. The Lords Commissioners of His Majesty's Treasury hereby give notice that Tenders will be received at the Chief Cashier's Office, at the Bank of England, on Friday, the 23rd January, 1948, at 1 p.m. for Treasury Bills to be issued under the Treasury Bills Act, 1877, the National Debt Act, 1889, and the National Loans Act, 1939, to the amount of £160,000,000.

2. The Bills will be in amounts of £5,000, £10,000, £25,000, £50,000 or £100,000. They will be dated at the option of the tenderer on any business day from Monday, the 26th January, 1948, to Saturday, the 31st January, 1948, inclusive, and will be payable at three months after date.

3. The Bills will be issued and paid at the Bank of England.

4. Each Tender must be for an amount not less than £50,000 and must specify the date on which the Bills required are to be dated, and the net amount per cent. (being an even multiple of one penny) which will be given for the amount applied for. Separate Tenders must be lodged for Bills of different dates.

5. Tenders must be made through a London Banker, Discount House or Broker.

6. The persons whose Tenders are accepted will be informed of the same not later than the following day, and payment in full of the amounts of the accepted Tenders must be made to the Bank of England by means of Cash or a Banker's Draft on the Bank of England not later than 1.30 p.m. (Saturday 12 noon) on the day on which the relative Bills are to be dated.

7. Members of the House of Commons are not precluded from tendering for these Bills.

8. Tenders must be made on the printed forms which may be obtained from the Chief Cashier's Office, Bank of England.

9. The Lords Commissioners of His Majesty's Treasury reserve the right of rejecting any Tenders.

LONDON HACKNEY CARRIAGES ACT, 1850.

CAB STANDINGS.

Notice is hereby given that in pursuance of Section 4 of the London Hackney Carriages Act, 1850, the Commissioner of Police of the Metropolis has issued Orders, dated 19th December, 1947, appointing the following Cab Standings: a Standing for twenty-two hackney carriages and a further Standing for seven hackney carriages at Piccadilly, W. (Albany); a Standing for forty-five hackney carriages at Strand, W.C.; a Standing for eleven hackney carriages at Strand, W.C. (north side of St. Mary-le-Strand Church). He has also made Regulations regarding these Standings.

The Order and Regulations, dated 16th May, 1933, with regard to a Standing for twenty-five hackney carriages at Piccadilly (Albany), the Order and Regulations, dated 22nd December, 1931, with regard to a Standing for fifty-two hackney carriages at Strand, W.C., and the Order and Regulations dated 10th March, 1938, with regard to a Standing for five hackney carriages at Strand, W.C. (north side of St. Mary-le-Strand Church), are revoked.
