

" And whereas the said President and Scholars, the said Maria Thereza Eugenie Plummer and the said Warden and Scholars Clerks are each desirous of transferring their shares in the right of patronage in respect of the said benefice to the Bishop of Winchester for the time being and are consenting to this Scheme (in testimony whereof they have executed the same)

" And whereas we are satisfied that the transfer will tend to make better provision for the cure of souls

" Now, therefore, with the consent of the Right Reverend Mervyn, Bishop of Winchester (in testimony whereof he has executed this Scheme), we, the Ecclesiastical Commissioners for England, humbly recommend and propose that upon and from the day of the date of the publication in the London Gazette of any Order of Your Majesty in Council ratifying this Scheme and (without any conveyance or assurance in the law other than such duly gazetted Order, the whole interests of the said President and Scholars, the said Maria Thereza Eugenie Plummer and the said Warden and Scholars Clerks respectively in the advowson or perpetual right of patronage of and presentation to the said benefice shall be transferred to the said Mervyn, Bishop of Winchester, and his successors in the same Bishopric to the intent that the whole advowson or perpetual right of patronage of and presentation to the said benefice shall thereupon and thenceforth become and be absolutely vested in and shall and may from time to time be exercised by the Bishop of Winchester for the time being "

And whereas the said Scheme has been approved by His Majesty in Council

Now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to ratify the said Scheme, and to order and direct that the same and every part thereof shall be effectual in law immediately upon the publication of this Order in the London Gazette pursuant to the said Acts.

And His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said diocese of Winchester

WHEREAS the Ecclesiastical Commissioners for England have duly prepared and laid before His Majesty in Council a Scheme bearing date the 11th day of December, 1947, in the words and figures following, that is to say —

" We, the Ecclesiastical Commissioners for England acting in pursuance of the New Parishes Measure, 1943, have prepared and now humbly lay before Your Majesty in Council the following Scheme for altering the boundaries of the parish of Spalding and of the parish of Saint Paul, Spalding, both in the diocese of Lincoln

" Whereas we are satisfied that it is desirable that the boundaries of the said parishes should be altered in the manner hereinafter mentioned

" And whereas the Bishop of the diocese consents to the proposed arrangements (in testimony whereof he has signed this Scheme)

" Now, therefore, we, the said Ecclesiastical Commissioners for England, humbly recommend and propose that from and after the day of the date of publication in the London Gazette of any Order of Your Majesty in Council ratifying this Scheme the boundaries of the said parish of Spalding, and of the said parish of Saint Paul, Spalding, shall be altered in the manner described in the Schedule and delineated on the map annexed to this Scheme

" *The Schedule to which the foregoing Scheme has reference*

" The territory (coloured pink on the attached plan) to be annexed to the said parish of Saint Paul, Spalding —

All that portion of the said parish of Spalding which is bounded on the east by the parish of

Weston, on the north by the said parish of Saint Paul, Spalding, and on the remaining sides, that is to say, on the west, the south west and the south, by an imaginary line commencing at a point in the middle of the River Welland, where it is crossed by West Elloe Bridge, on the boundary which divides the said parish of Saint Paul, Spalding, from the said parish of Spalding and extending thence south westwards along the middle of the said river for a distance of 20½ chains or thereabouts to a point opposite to the middle of the western end of Albert Street, and extending thence south eastwards crossing Commercial Road to and then along the middle of Albert Street to its junction with Halmer Gate, and extending thence to the middle of the last mentioned Gate and thence first north eastwards and then south eastwards along the middle of Low Roads to its junction with Rangell Gate, and extending thence southwards to and along the middle of Rangell Gate to the centre of the level crossing which carries the Midland and Great Northern Joint Railway running from Spalding to Holbeach, and extending thence eastwards along the middle of the said railway to the boundary which divides the said parish of Spalding from the said parish of Weston "

And whereas the provisions of the New Parishes Measure, 1943, relating to the preparation and submission of this Scheme have been duly complied with

And whereas the said Scheme has been approved by His Majesty in Council

Now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to ratify the said Scheme, and to order and direct that the same and every part thereof shall be effectual in law immediately upon the publication of this Order in the London Gazette pursuant to the said Acts

WHEREAS the Ecclesiastical Commissioners for England have duly prepared and laid before His Majesty in Council a Scheme bearing date the 11th day of December, 1947, in the words and figures following, that is to say:—

" We, the Ecclesiastical Commissioners for England, acting in pursuance of the Act of the 6th and 7th years of His late Majesty King William the Fourth, Chapter 77, of the Act of the 3rd and 4th years of Her late Majesty Queen Victoria, Chapter 113, and of the Act of the 37th and 38th years of Her said late Majesty Chapter 63, have prepared and now humbly lay before Your Majesty in Council the following Scheme with respect to some of the rural deaneries within the archdeaconries of Basingstoke and Winchester, both in the diocese of Winchester

" Whereas it has been represented to us by the Right Reverend Mervyn, Bishop of Winchester, that the arrangements which are hereinafter recommended and proposed with respect to three of the rural deaneries within the said two archdeaconries are desirable and we are of the opinion that the same may be properly carried into effect

" Now, therefore, with the consent of the said Bishop (in testimony whereof he has signed and sealed this Scheme) we, the said Ecclesiastical Commissioners, humbly recommend and propose that as from the day on which any Order of Your Majesty in Council ratifying this Scheme shall be published in the London Gazette, and without any assurance in the law other than such duly gazetted Order, first, the whole of the rural deanery of Alresford consisting of the parishes or cures specified in the First Part of the Schedule hereto shall be transferred from the said archdeaconry of Winchester to the said archdeaconry of Basingstoke and, secondly, the parish or cure specified in the Second Part of the said Schedule shall be transferred from the rural deanery of Christchurch to the rural deanery of Bournemouth, both of which said rural deaneries are in the said archdeaconry of Winchester, and each of the parishes or cures mentioned in the said Schedule shall be subject to the jurisdiction and authority of the rural
