## LONDON TRAFFIC ACT, 1924

Notice is hereby given that it is proposed by the Minister of Transport after the expiry of at least the Minister of Transport after the expiry of at least 40 days from this date in pursuance of the powers conferred upon him by section 10 of the London Traffic Act, 1924, to make Regulations (1) to institute unilateral waiting between the hours of 8 a m and 8 p m, and (2) to prohibit the waiting of vehicles on parts of the London-Portsmouth Trunk Road at Ripley, as shown in the Schedules hereto Exceptions will be provided in the Regulations to enable a vehicle to wait for so long as may be necessary
