A PROCLAMATION,

For the Apprehending all Persons going to or from France, and also for the Taking and Apprehending of all Deserters from Her Majesty's Service in the Army Abroad.

ANNE R.

WHEREAS by an Act made in the Ninth Year of the Reign of Our late Royal Brother King William the Third, It is Enacted, That if any of His said Majesties Subjects, who had at any time since the Eleventh Day of December, One thousand six hundred eighty eight, Voluntarily gone into France or any of the French Kings Dominions, without Licence from His said late Majesty, or Our late Royal Sister Queen Mary, or at any time, during the late Wars with France, born Arms in the service of the French King, either by Sea or Land, should at any time after the Eleventh Day of January, One thousand six hundred ninety seven, Return into this Kingdom of England, or any other His said late Majesties Dominions, without Licence under the Privy Seal, every Person, so Offending, shall (being Lawfully convicted thereof) be Taken, Detained and Imprisoned to be Guilty of High Treason, and shall suffer and forfeit as in Cases of High Treason.

And whereas We are Informed, That notwithstanding the said Act, and that We are now actually Engaged in War against France, divers of Our Subjects, who by the said Act are Prohibited to Return to any of Our Dominions, without Our Licence under Our Privy Seal first Obtained, do privately Return to this Our Realm, and others of Our Subjects do Endeavour to Transport themselves from this Our Realm into the Dominions of the French King, whereby a Correspondence is and may be Maintained, and Carried on with Our Enemies, to the Prejudice of Us and Our Kingdoms: We have therefore Thought fit, and do hereby, (with the Advice of Our Privy Council) strictly Prohibit and Forbid all and every Person and Person whatsoever, being Our Natural Born Subjects, from returning into Our Dominions contrary to the said Act, and from going to France, or any other the Dominions of the French King, during this present War.

And whereas We are Informed, That divers Soldiers and others, who have received Our Pay, and been actually Employed in Our Service in Our Army abroad, have Deserted from their Duty, and Deserted Our said Service there, and secretly Returned into this Our Kingdom of England, to the Dishonour of their Country, and Our great Displeasure in this time of Publick Danger: We do hereby therefore Charge and Command all, and singular Our Lieutenants, Deputy Lieutenants, Mayors, Sheriffs, Justices, Constables, Headboroughs, and other Our Officers, Ministers and Subjects whatsoever, within this Realm, to make Search for, and use their utmost Endeavours to Discover, Take and Apprehend all, and every Person and Person, Our Natural Born Subjects, who have or shall Return into this Our Kingdom contrary to the said Act, and also who shall Voluntarily Go or Embark in any Ship or Vessel, with any intent to go into any of the Dominions of the French King, without Our Royal Licence first Obtained; and also all, and every such Soldier and Soldiers, who having been engaged in Our Service in Our Army abroad, and have Deserted or shall Desert from such Our Service, and shall be found in this Our Kingdom; and such of the Officers as aforesaid, as shall be so Apprehended to carry them to the next or some other Justice of the Peace, where they shall be so Apprehended, who is hereby Required to Commit them to the Common Goal of the County, where they shall be so Apprehended, there to remain until they shall be taken and removed by due course of Law, and forthwith to Cause the Names of the Persons so Apprehended and Committed, with their particular Cases, and by whom Apprehended, to one of Our Principal Secretaries of State, in due Care may be taken for their speedy Prosecution accordingly.

And We do hereby Promise and Declare, That whatsoever shall, during this present War, Discover and Apprehend any Person or Persons, who shall return from France contrary to the said Act, or who shall go to, or Embark in any Ship or Vessel with intent to go to any of the French Kings Dominions, and shall bring such Person and Persons, so Taken and Apprehended before the next, or some other Justice of the Peace, in order to their being Committed and Proceeded against according to Law, shall for every such Person so Taken and Apprehended and brought before Justice of the Peace or Chief Magistrate, Receive as a Reward the Sum of Forty Pounds of Lawful Money of England, which Our High Treasurer or the Commissioners of Our Treasury for the time being, is and are hereby Directed to Pay according; And for the Doing thereof, this Our Royal Proclamation shall be a sufficient Warrant without any further Direction in that behalf.

And We do hereby further Direct and Require all Our Officers aforesaid, that they do cause every Person coming into this Our Kingdom, from the French or Spanish Dominions, during this present War, to appear before one of Our Justices of the Peace, to be Examined concerning such Persons coming into this Our Realm: And if such Justice of the Peace on such Examination, shall find reasonable Cause to suspect such Persons coming to it with design to Disturb Our Government, or that such Person hath had any Correspondence with Our Enemies, he is hereby Required to take sufficient Security for such Persons appearing in Our Court, called the Queens Bench at Westminster, in the then next Term, and in Default thereof, to Commit such Person to the Common Goal of the County or Place, where he shall be Apprehended, there to remain till Discharged by Due Course of Law, and thereof immediately to give Notice in Writing to one of Our Principal Secretaries of State.

Given at Our Court at St. James's the Eighteenth Day of June, 1702. In the First Year of Our Reign.

A PROCLAMATION.

ANNE R.

WHEREAS We have been Informed, That notwithstanding the Encouragement given by Our late Royal Brother King William the Third, by His Royal Proclamations Dated the Eighth of January, and Twelfth of February last, for Seamen to Enter themselves on Board His said Majesties Ships of War, divers Seamen and Mariners, for whose Service we have Present Occasion, have lately Left their Usual and Ordinary Places of Abode, and have Removed themselves into Private and Obscure Places in and about Our Cities of London and Westminster, and Borough of Southwark, and Parts Adjacent, and elsewhere, Encouraging thereby to Avoid Our Present Service: We therefore (by the Advice of Our Privy Council) have thought fit to Publish this Our Royal Proclamation, and do hereby strictly Charge and Command all Seamen and Mariners, now being and remaining in any County of England or Wales, and not already Listed, or Entered into Our Service, That they forthwith Render themselves into the Principal Officers and Commissioners of our Navy in London, or to the Commissioners of the Navy at such Ports and Places that shall be nearest to the Place where they now are, in Order to their being Received into Pay, and Sent on Board such of Our Ships of War, as shall be found most Expedient for Our Service; And Declare, if any of them shall hereafter be Found out or Discovered to have Neglected to Obey this Our Royal Command, they shall be Proceeded against with all Severity of Law for such their Contempt. And for the Encouragement of all such Seamen, and Able-Bodied Landmen, with greater Alacrity and Cheerfulness to Enter themselves in Our Service, and Remain on Board Our Ships of War in Our Royal Navy, We do hereby Promise and Declare, That if any Seaman, or Able-Bodied Landman (other than such who shall Desert any of Our Ships of War,

War, in Order to Obtain Our intended Bounty, whom We hereby Direct to be Prosecuted for such Desertion) shall on or before the Fifteenth Day of July now next ensuing, Enter himself with any Justice of the Peace or Vice-Admiral, to Serve Us in Board of Our Ships of War, such Justice of the Peace, or Vice-Admiral respectively, shall give to each Man, so Entering, a Certificate, under his Hand and Seal, of his Entry, and the Time of his Entry, and shall Limit such a Number of Days in the said Certificate, as may be necessary for his Repairing on Board some Ship or Tender in our Service (which Certificate shall be Granted without any Fee or Reward, and that then a full such Seaman and Able-Bodied Landman who shall, within the Time Limited in such Certificate, Repair on Board any of Our said Ships or Tenders, on Producing a Certificate thereof from the Officer of such Ship or Tender, shall have and Receive, as Our Free Gift and Royal Bounty, from Our Principal Officers of the Navy, or such Person as they shall appoint, the Sum of Twenty Shillings, he or she such Ship, and Depart to Sea. And to the end We may be Informed what Persons shall so Enter themselves to Serve on Board Our Fleet, in Pursuance of this Our Proclamation, We do hereby Require and Command Our Respective Justices of the Peace and Vice-Admirals within this Kingdom of England, and Dominions of Wales, to Transmitt to the Commissioners of Our Navy, Lists containing the Christian and Surnames of each Person that shall Enter with them, the Time of their Entry, for what Ship, and the Time which shall be given to each Person to Repair on Board. And We do hereby further Charge and Command all Our Captains, Commanding any of Our Ships of War, to Transmitt to the Commissioners of Our Navy, true Accounts in Writing, under their Hands, of the several Times when the said Men shall respectively come on Board. And We are also solemnly moved to Declare, That Conduct-Money, according to the Practice of the Navy, (over and besides Our said Bounty-Money) shall be allowed to such Seamen and Landmen as shall Voluntarily Enter themselves for Our Sea Service, according to the true Meaning of this Our Royal Proclamation. And We do hereby Require and Command the Lord Mayor of Our City of London, and all Our Justices of the Peace, Constables, and other Officers of Our Cities of London and Westminster, County of Middlesex, and Boroughs of Southwark in the County of Surrey, and other the Parts and Places near adjoining to the same, That they do make, or cause to be made, diligent Search, within all and every their Precincts and Jurisdictions, for the said Seamen and Mariners, and Seize and Seize, or cause to be Seized and Secured, the Persons of such of them as shall be there found (other than such who shall have Entered themselves, as aforesaid, within the Time Limited, as aforesaid, for his or their Repairing on Board Our Ships of War; and other than such as are or shall be Protested, as being in Our immediate Service Employed by the Commissioners of Our Navy, Officers of Our Ordnance, Commissioners for Victualling Our Fleet, or Our Commissioners for Transportation) and cause them to be sent and put on Board such of Our Ships or Tenders that shall be appointed to lie in the River of Thames to Receive them, in order to their being Employed in Our Service; And that they do also send up to the Commissioners of Our Navy, a List of the Names of all such Seamen and Mariners as they shall procure for the Service aforesaid. And the Officer to whom such Seamen or Mariners shall be delivered (and whom We hereby Require and Command to Receive none but such as are fit for Our Service) shall give Certificates or Receipts in Writing, under their Hands, for such of them as shall be so delivered in pursuance hereof. And for the Encouragement of all Constables, and other Inferior Officers, to be Diligent in the Searching after, Taking and Securing such Able Seamen and Mariners, who shall Neglect or Refuse to Enter themselves in Our Service, as aforesaid, We do hereby Promise and Declare, That every such Constable, or other Inferior Officer, who shall Secure and Deliver, or cause to be Delivered on Board any of Our said Ships or Tenders in the River of Thames, appointed or to be appointed to Receive them, any such Seaman or Mariners, as aforesaid, on or before the Fifteenth Day of July now next ensuing, shall, upon producing to the Commissioners of Our Royal Navy such Certificate or Receipt, as is hereby before required to be given for such Seaman or Mariners as shall be so delivered, receive of Our said Commissioners, as Our Free Gift and Royal Bounty, in Reward of such their Service, Ten Shillings for every such Seaman and Mariner as shall by him be Delivered or caused to be Delivered on Board, as aforesaid; which Reward Our said Commissioners are hereby required to pay accordingly. And whereas We are informed, That divers Seamen and Mariners, fit for Our Service at Sea, do procure themselves to be Chosen into Parish-Offices, hoping thereby to Avoid such Our Service, for which they are proper, We do hereby therefore Recommend it to all Our Loving Subjects whatsoever, who are or shall be in any way concerned in the Electing and Constituting of such Officers, that, as far as in them lies, (during this present War) they do Forbear and Avoid putting or admitting to such Offices any Seaman or Mariners requisite and

necessary for Our Service and the Defense of their Country on Board Our Fleet.

The following Address was presented to Her Majesty.
To the most Illustrious and High-born Princess ANNE,
by the Grace of GOD, Queen of England, Scotland,
France, and Ireland, Defender of the Faith.

The most humble Address of the President, Vice-President,
Treasurer, Court of Assistance, and Body of the
Artillery Company in the City of London.

Permit us, mighty Queen, to Condole with the rest of
your Faithful Subjects, for the Death of our late most
Glorious and Heroic Sovereign of Immortal Memory
William III. the Deliverer of these Nations from Impending
Slavery and Superstition, the Restorer and Maintainer of
the Liberties of Europe, and Protector of the Protestant
Interest in all the Parts of the Earth.

But of all the Obligations he laid upon the People of Eng-
land, what we must ever remember, with the most feeling
Sense of Gratitude, is, the Preserving Your Majesty from
being excluded from the Throne; your Accession to which we
congratulate with the greatest Sincerity, having not only
the most Rightful and Lawful Title in the World, but us-
ing likewise the worthiest to succeed our deceased Monarch,
by your rash taken Assistance to the Church of England; your
entire Disposition to render Conscience your glorious
Religion of humbling Prayers, of supporting your Allies,
maintaining the Succession of the Crown in the Protestant
Line, and encouraging the peaceable Professions of Arts and
Trade in the midst of tumultuous Wars.

According to the Institution of our Company we promise
to do our best in training your loyal Citizens to the Use of
Arms, for the Security of your Royal Person, Title, and
Dignity, and the Preservation of those Blessings so much
worth fighting for, which Citizens can only enjoy in a free
Government, and under so Excellent a Prince. And in all
Humility we pray, that Your Majesty would be graciously
pleas'd to appoint us a Captain-General, which George the
late King did us the Honour to take upon himself, accord-
ing to the Example of some of your Royal Predecessors.
And on our parts we will never be wanting in Gratitude
or Duty, with the Hazard of our Lives and Fortunes, to
support your Cause and Person, against the pretended Prince
of Wales, and all Your Majesty's open or secret Enemies
whatsoever.

Witchell, June 24. The Three Poits that were due
from Holland came in late this night, and bring the
following Advices:

Hague, Jun 30. N. S. The King of Prussia came hither
the 23d Instant, and was received with the Honours
due to his Rank and Dignity. The Earl of Athlone
has been here to receive new Instructions from the
States General, and is since returned to his Army, which
continues in the same Poits, part of the road before
Nimwegen, and the rest with the Horse along the
Rhine; they hourly expect to be joined by 6000 Men
of the forces of Hesse, and two Regiments of those of
Prussia; as also by Troops of Lunenburg, which are
arrived at Amsham in Consideration. The French Gar-
rison is march'd out of Keylerwaert, and the French
have since our taking that Place abandoned Nuy and
Zand, which have put themselves under the Emperor's
Protection; The best part of the Forces employ'd in
that Siege are marching down the Rhine to join the
Earl of Athlone, upon which Count Taland has re-
joined the Duke of Burgundy's Army, which is still in
the same Camp near Cleves.

Strasbourg, June 25. Prince Lewis of Baden decamp'd
the 10th from Laigenselden, in order to form the
Siege of Landau, and accordingly having posted his
Army about that Place, the Trenches were opened the
12th. The Allies have a strong body of Horse near
Luzon Weisenbourg to observe Marshal Catmar's Ar-
my, which is still encamp'd near Hagenau.

Paris, June 16. N. S. The Imperial Army under
Prince Eugene continues in the same Camp near Cleves;
The French Army remains still in a Line from
the Neighbourhood of that Place to Mannheim; Be-
sides which the French have a strong Camp in the Mar-
shes near Strasbourg. The Germans have received
another Remonstration, and are under no Apprehension
of the French; they lately made an Attempt to sur-
prise the Lake of Vendome in his Quarters, which
ended in success, through the Inprudence of one of
the Party employ'd in that Design, who fell upon a
Centinel, and alarm'd the French.

Bristol, June 22. The Little Bristol, John Ring Ma-
ster, arriv'd here the 20th Instant from Newfoundland.
The same day came in here the Happy Return Engage-
ment from Jamaica, having spent 7 weeks in her Pas-
sage: The Master reports, that he lost the Squadron of
Her Majesty's Ships under the Command of Admiral
Lambow at Jamaica; but that he met afterwards with
a sloop which came from thence, and gave an Account,

that the said Squadron put to Sea about 6 weeks ago
but does not say whether they failed.

Comes, June 22. The Rose-tree of Middleburgh, a
Caper of 13 Guns, Peter Burrence Commander, came
in here yesterday with a small French Privateer belong-
ing to Brazil, which he took in the Channel; He had before
sent home another Prize, being a French Merchant Ship
laden with Wine and Brandy.

Portsmouth, June 23. Rear-Admiral Fairborne and
Rear-Admiral Granton, with one Dutch Flag and 20
Men of War, English and Dutch, sail'd yesterday from
St. Helens. Sir George Cooke continues there with Her
Majesty's Fleet. Sir Cloudesly Shovel is at Spithead, with
a strong Squadron of Men of War.

Yesterday a small French Privateer being chased in at
the Needles, and endeavouring to get out at St. Helens,
was taken by Her Majesty's Ship the Affliction.

Dover, June 23. Her Majesty's Ship the Galeser and
the Merlin sloop came into the Downs late Sunday, hav-
ing under their Convoy the Mary Galleys, Thomas Har-
rison Master, from Seville; the Penelope, John Brid-
ges Master, from the Mediterranean; the Royal Galleys from
Leghorn; the Mars, William Jervis Master, from
Lisbon, and about 11 or 12 small homeward-bound
Merchant ships. This day 8 of Her Majesty's Ships,
and one Bound-Return, sail'd from the Downs to the
Westward, with divers Victuals, store-ships, Tenders,
and Coasters, and two Dutch Transport Ships
which came under the Sunday with soldiers from
Holland.

St. James's, June 22. This day Count Jergen,
who is sent by the Emperor with the Character
of his Envoy Extraordinary, to make his Com-
pliments of Condoleance and Congratulation to
Her Majesty upon the late King's Death and
Her Majesty's Succession to the Crown, had
Publick Audience of Her Majesty; being in-
troduced by Sir Charles Cottrill Master of the
Ceremonies.

After which he had Audience of His Royal
Highness Prince George of Denmark; being in-
troduced in like manner.

His Royal Highness Prince George of Denmark
has appointed Edward Nicholas Esq; to be his
Treasurer.

St. James's, June 24. This day the Count de
Maffey, Envoy Extraordinary from the Duke of
Saxony, had Publick Audience of Leave of Her
Majesty; being introduced by Sir Charles Cottrill
Master of the Ceremonies.

After which he had likewise his Audience of
Leave of His Royal Highness Prince George of
Denmark.

St. James's, June 24. The Queen has been
pleas'd to appoint his Grace the Duke of Devon-
shire, Lord Steward of Her Majesty's Household;
to be Lord Lieutenant of the County of Derby;
his Grace the Duke of Ormond to be Lord Lieuten-
ant of the County of Somerset; his Grace
the Duke of Northumberland Lord Lieutenant
of the County of Surrey; his Grace the Duke
of Bolton Lord Lieutenant of the Counties
of Dorset and Southampton; his Grace the Duke
of Shrewsbury Lord Lieutenant of the Counties
of Hereford and Worcester; his Grace the Duke
of Bedford Lord Lieutenant of the Counties of
Bedford, Cambridge and Middlesex; his Grace the
Duke of Newcastle Lord Lieutenant of the Coun-
ty of Nottingham, and of the East-Riding of the
County of York; the Rt. Hon. the Earl of
