EXPLANATORY NOTE

These Regulations contain miscellaneous provisions affecting widow's benefit, guardian's allowances and retirement pensions, and relate to pensions where the widow is incapable of self-support (regulation 2), the relaxing for the purposes of widow's pensions of the condition as to the duration of marriage in the case of widows married more than once (regulation 3), modification of the conditions for guardian's allowances in the case of adopted and illegitimate children (regulation 4), additional conditions for retirement pensions by virtue of the husband's insurance in the case of women marrying after pensionable age (regulation 5), the choice of retirement pension by women who, but for the provisions prohibiting double entitlement, would be entitled to more than one retirement pension (regulation 6); priority as between a man and his wife to an increase of retirement pension for a child (regulation 7), and These Regulations contain miscellaneous provisions of retirement pension for a child (regulation 7), and the payment of benefit at reduced rates in the case of deficient contribution records (regulation 8)
